- **MFF Package**

In relation to the proposal for a Regulation of the European Parliament and of the Council establishing the Strategic Technologies for Europe Platform ('STEP'), Coordinators agreed to ask for the application of Rule 58 in view of the amendments to the RRF and InvestEU Regulations.

## **3. Public hearings**

- **State Aid: EU's reaction to the US Inflation Reduction Act (IRA)**

Coordinators agreed that further attempts should be made to organise a public hearing with Commissioner Breton on "*State Aid: EU's reaction to the US Inflation Reduction Act (IRA)*".

- **European Gender Equality Week**

Coordinators agreed that the availability of the speakers (included in the previously agreed programme of the ECON-FEMM high level event) should be checked for week 43 (Gender Equality Week). Coordinators will decide at their next meeting how to proceed (in cooperation with FEMM).

## **4. Question for oral answer to the Commission: A single market for Philanthropy**

Following a short exchange of views, Coordinators agreed that there would be no follow-up to the request for a question for oral answer on "*A single market for Philanthropy*".

After the cancellation of the third trilogue expected on 12 June, the final inter-institutional negotiations on the review of MiFIR and MiFID took place on 29 June, when a provisional agreement was reached. It includes an agreement on the consolidated tape, the ban on payment for order flow (PFOF) and on commodities. Work at technical level is now ongoing in view of the reconsultation in COREPER II and ECON in due course.
