2. End of the 9th legislature

- **Political prioritisation process**

Following the request by the CCC Chair to Committees to indicate the priority

files to be adopted during this legislature, representing up to a maximum of one quarter of respective ongoing files, it was agreed to give priority to all files that are currently in trilogue or expected to be in trilogue with the aim to reach an agreement during the current term.

- **ECON “end of term report”**

Coordinators approved the concept of the ECON “end of term report” and the structure set out in the note by the secretariat. The report should be available on the EP website (no printed copies). As regards legislative files, there should be a brief description of the content and the EP’s achievements, as well as a short quote if possible by the Rapporteur. Information on consultation files, opinions, committee activities etc. should simply be listed.

3. Any other business

It was agreed to organise a presentation of the SRB report [“Small and medium-sized banks: resolution planning and crisis management report for less significant institutions in 2022 and 2023”](#) of 3 October 2023 at a BUWG meeting.

6. Report on ongoing interinstitutional negotiations

1. Instant Payments: 2nd trilogue of 7 November 2023

On 7 November 2023, the second trilogue was held on the regulation on instant payments (Rapporteur: Michiel Hoogeveen, ECR). It was eventually able to conclude the negotiation after being suspended at lunchtime and then reconvened in the evening. The most difficult issue was the question of 24 hour availability to send instant payments in euros from non-euro accounts held in non-euro countries, the concern being that the relevant banks and other payment services providers might not have access to the required euro liquidity outside business hours. The negotiated solution was that non-euro countries would first have a longer transition period before those banks and providers had to provide instant credit transfers in euros (both inside and outside business hours), and thereafter have the possibility to allow to set a ceiling for such transfers outside business hours. Parliament and Commission were keen to set that ceiling as high as possible in order to be useful to small businesses and larger retail payments, and agreement was reached on the level of 25 000 euros. Agreement was also reached to amend the Settlement Finality Directive in order to allow payment institutions and electronic money institutions to send instant credit transfers, and on the overall timetable for introduction of instant payments.

Provided the text is finalised and adopted as expected before the European elections, citizens in the euro area will be able to send instant payments in euros across the whole euro area, at no extra cost above regular transfers, at the latest in autumn 2025.

2. Joint ECON-LIBE file: AMLA, 7th and 8th trilogue (9 November and 14 November 2023)

On 9 November 2023, the seventh trilogue on the regulation establishing the new AML Authority (AMLA) took place (Co-Rapporteurs: Eva-Maria Popovska, Renew, ECON; Emil Radev, EPP, LIBE). It focused on the organisation of hearings of applicants and on the modalities for the selection process regarding the determination of the seat of the new Authority. The co-legislators agreed to organise jointly public hearings of all applicants that submitted an application by the deadline (10 November 2023). Mandate was given to the technical level to work out the modalities for organising the joint public hearings. The co-legislators agreed to convene the next trilogue on this issue on 4 December (to be confirmed).

On 14 November 2023, the eighth trilogue on the AMLA regulation was organised, focusing on supervisory matters. The co-legislators discussed in particular the key provisions on direct supervision in the financial sector, i.e. how to assess and to select obliged entities in the financial sector that will fall under direct supervision by AMLA. Co-legislators also further discussed the framework to be put in place on indirect supervision in the financial sector, in order to ensure supervisory convergence in the financial sector. Another topic of discussion concerned indirect supervision in the non-financial sector. Finally co-legislators addressed some provisions dealing with the legal instruments at the disposal of AMLA, where agreement was reached.

3. Daisy Chain: 1st trilogue of 22 November 2023

On 22 November 2023, the first trilogue on the daisy chain Directive amending BRRD/SRMR took place (Rapporteur: Jonás Fernández, S&D). On this occasion, co-legislators discussed measures relating to the mechanisms of deduction for internal MREL (the minimum requirement for own funds and eligible liabilities) in order to ensure proportionality and a level playing field between holdco and opco banking groups. The main political issue was whether the liquidation entities should be removed from this deduction

mechanism. A mandate was given to the technical level, to work on a possible compromise proposed by the Commission, to introduce a partial exclusion of liquidation entities in the form of a cap to their own funds subject to deduction. The next trilogue is planned for early December.

4. Solvency II Review: 4th trilogue of 22 November 2023

On 22 November 2023, the fourth Trilogue on the Solvency II Review took place (Rapporteur Markus Ferber, EPP). On the basis of several Commission non-papers discussions were held on 1) Long-Term Guarantees/Long-term Equity, 2) Sustainability, 3) Proportionality, 4) Cross-border activities, 5) Reporting and Auditing, 6) Group Supervision, 7) Macroprudential Supervision, and 8) Securitisation. Incremental steps towards an overall agreement were taken. The next trilogue is scheduled on 13 December 2023.

5. IRRD, 4th trilogue of 23 November 2023

On 23 November 2023, the fourth Trilogue on the IRRD took place (Rapporteur Markus Ferber, EPP). On the basis of a number of Commission non-papers, the three institutions continued their discussions on 1) exclusions from the write-down and convergence tool, 2) the selection criteria for undertakings subject to planning requirements, 3) pre-emptive recovery planning and resolution planning, 4) EIOPA mandates, 5) conditions for resolution, 6) financing arrangements, 7) national protection schemes used as a bridge undertaking, and 8) the review clause. The next trilogue is scheduled on 14 December 2023.

6. Listing package: 1st Trilogue of 23 November 2023

On 23 November 2023, the first trilogue on the Listing package took place. Co-legislators, along with the Commission, tackled the main political matters identified on the Multiple vote share structure and MIFID Directives as well as the Prospectus and MAR Regulations. The discussions will continue at technical level. The next trilogue is scheduled on 14 December.
