The Chair made a brief announcement on the interpretation facilities available for the meeting.

2. Joint ECON-LIBE file: AMLR, Fifth Trilogue (29 November)

On 29 November, the fifth trilogue on the regulation on the prevention of the use of the financial system for the purposes of money laundering or terrorist financing (AMLR) took place. Co-legislators provisionally agreed on requirements for different categories of obliged entities such as traders of precious metals and stones or persons trading in works of art / cultural goods. For other categories of obliged entities such as football clubs a mandate was given to technical level. Co-legislators also provisionally agreed on customer due diligence measures towards self-hosted wallets. They mandated the technical teams to work further on a couple of other topics such as scope of politically

exposed persons (PEPs) and high-net worth individuals (HNWI), third country policies and residence by investment schemes.
