4.1. *Follow-up of the Porto and Lisbon Conference*

The Chair reported back from the Porto and Lisbon Conference and thanked the Coordinators, the Rapporteur and the shadow Rapporteurs for the affordable housing and their respective teams for the excellent cooperation. They agreed that the association “Romador”, one of the award-winning NGO in Lisbon active in homelessness/Roma community, would be invited at a forthcoming EMPL meeting to report on their experience on the ground.

The Chair also informed the Coordinators that she already informed the upcoming Slovenian Presidency that the Parliament will not accept that the situation of the Porto and Lisbon declaration repeats. If a Presidency wants the Parliament to co-sign a declaration, then the Parliament must be on an equal footing with the other signatories, and must be involved in the drafting and negotiations from the very beginning (as was the case for the Gothenburg declaration in 2017).

4.2. *Update on Pilot projects and preparatory actions*

Background

In view of the current work of EMPL committee on the Directive for the Minimum Wage Directive, the co-rapporteurs (S&D co-rapporteur Agnes Jongerius and EPP Dennis Radtke) would like to ask coordinators to decide on a formal legal assessment by the European parliament Legal Service on the EC Proposal for the Minimum Wage Directive.

This formal legal assessment is necessary for the two co-rapporteurs in order to enhance our arguments towards the formal legal assessments already provided by the EC and the Council Legal Service on the said proposal.

The formal legal assessment could further elucidate the legal basis of article 153 of the TFEU and / or more articles TFEU that could serve as a legal basis to the various articles of the Proposal Directive and the procedural aspects of the proposal.

In addition, the Co-rapporteurs would like to invite the Legal Service to assess any other noteworthy aspects which might arise during the negotiations of the legislative report and they will welcome any other legal relevant aspect that is not covered explicitly by this request.

This is an urgent request having in mind the tentative planning of shadow meetings.

They request that legal opinion for the use of the co-rapporteurs and the coordinators should be drawn up in English.

The RRF Working Group met on 17 June to exchange views with Ms Céline Gauer, Head of the Recovery and Resilience Task Force (DG RECOVER) on the Commission's follow-up to the EP resolution of 10 June 2021 "European Parliament's Scrutiny on the ongoing assessment by the Commission and the Council of the national recovery and resilience plans". In its meeting on 24 June, the RRF Members exchanged views with Ms Céline Gauer, Head of the Recovery and Resilience Task Force (DG RECOVER) as regards social cohesion, implementation of the Social Pillar, and policies for the next generation. Please see enclosed in the documents for information the Proposals for Council implementing decisions on the approval of the assessment of the recovery and resilience plans for Austria, Latvia, Germany, Italy.

9th RRF WG on 24 June - COM presentation

2 Council activities from 14/06/2021 to 25/06/2021

On 14 June 2021, the Employment and Social Ministers (EPSCO) adopted a [recommendation establishing a European Child Guarantee](#). The aim of the recommendation is to prevent and combat social exclusion of children by guaranteeing access of children in need to a set of key services, thereby also helping to uphold the rights of the child by combating child poverty and fostering equal opportunities. The Council also adopted [conclusions on teleworking](#), on the [Socio-Economic Impact of COVID-19 on Gender Equality](#) and on the Strategy for the Rights of Persons with Disabilities 2021-2030. The presidency informed ministers about the state of play of the directive on adequate minimum wages. It also informed ministers about the state of play of a **number of ongoing legislative files**: a proposal for a directive on strengthening the application of the principle of equal pay for equal work or work of equal value between men and women and a Council directive to extend the protection against discrimination on the grounds of religion or belief, disability, age or sexual orientation to areas outside employment. For both proposals the Portuguese presidency presented a report summarising the state of play of the discussions among member states and the possible way forward to reach an agreement. The Council endorsed the assessment of the implementation of the 2020 and 2019 country-specific recommendations and the opinion of the Employment Committee and the Social Protection Committee for a **revised Social Scoreboard**, setting new headline indicators.

3 Summary Report 2021 [MM]

The Conference of Committee Chairs adopted the Summary Report 2021 at its meeting of 16 June. The document provides an introductory horizontal part addressing the remarks and concerns common to all committees and is followed by an overview of committees' positions bringing up their key messages to the Commission, particularly as regards the implementation of the CWP 2021 and committees' requests to be reflected in the CWP for the next year. As foreseen in the Framework Agreement, the Summary Report shall be the basis for Parliament's resolution on the future CWP as well as for future exchanges between committees and their respective Members of the Commission, particularly in the framework of the next meeting between the Conference of Committee Chairs and the College of Commissioners later this year.

The introductory part duly reflects the comments made by the EMPL Chair and the Annex includes the EMPL Committee's contribution in the framework of the Structured Dialogue. The Summary Report can be found amongst the annexes.

4 **Communication from the Commission: EU strategic framework on health and safety at work 2021- 2027 - Occupational safety and health in a changing world of work**³ [CK]

The EU strategic framework on health and safety at work, [published on 28 June 2021](#), identifies key challenges and actions to protect the almost 170 million workers in the EU from work-related accidents and diseases. It serves to mobilise EU institutions, Member States, social partners and other relevant stakeholders around common priorities on workers' protection and aims to ensure that the EU maintains its leadership role in promoting high standards for safety and health at work internationally.

In the light of making workplaces fit for the green, digital and demographic transitions, reflecting the changes to the traditional work environment, and drawing lessons from the COVID-19 pandemic, the 2021-2027 strategic framework focuses on three objectives:

- Anticipating and managing **change** in the new world of work;
- Improving **prevention** of work-related accidents and illnesses;
- Increasing **preparedness** for any potential future health crises.

Regarding digital transition: Together with other remote-working trends, such as permanent connectivity, a lack of social interaction, and increased use of Information and communications technology (ICT), this gives rise to psychosocial and ergonomic risks. As part of the new strategic framework, the Commission will among others review the [Workplaces Directive](#) and the [Display Screen Equipment Directive](#) (by 2023).

Regarding green transition: The Commission will propose protective limit values on asbestos in the [Asbestos at Work Directive](#) (in 2022), on lead and diisocyanates in the [Chemical Agents Directive](#) (in 2022), and on cobalt in the [Carcinogens and Mutagens Directive](#) (Q1 2024).

Regarding mental health: In cooperation with Member States and social partners, the Commission will prepare a non-legislative EU-level initiative related to mental health at work that assesses emerging issues related to workers' mental health and puts forward guidance for action before the end of 2022.

The EU strategic framework on health and safety at work 2021-2027 promotes a '**vision zero**' **approach** to work-related deaths in the EU. The last three decades have brought significant progress in occupational safety and health: between 1994 and 2018, fatal accidents at work in the EU decreased by about 70%. The ongoing legislative procedure on limits for acrylonitrile, nickel compounds and benzene under the [Carcinogens and Mutagens Directive](#) will help increase protection from carcinogenic and mutagenic substances for more than 1 million workers.

Regarding risk prevention: Preventing risks and promoting safe and healthy working conditions contributes to the well-being and health of workers and their families and improves companies' productivity and competitiveness.

Second-stage consultation of social partners (until 30 September 2021): on chemical agents at work (concerning lead and diisocyanates) and on exposure to asbestos at work (published on 28 June 2021).

Pandemic impact on OSH: The Commission will launch an in-depth assessment of the effects of the pandemic and the efficiency of the EU and national OSH frameworks to develop emergency procedures and guidance for the rapid deployment, implementation and monitoring of measures in potential future health crises, in close cooperation with public health actors.

Priority will be given to updating and expanding the protection of workers exposed to reprotoxic substances, in line with demands by the European Parliament. Reprotoxicants can have two groups of different effects: (i) effects on sexual function and fertility; and (ii) effects on the development of the foetus or offspring. These are serious health risks, and they can lead to spontaneous abortion, stillbirth, or impaired cognitive development of the conceived children. According to a worst-case-scenario estimate, reprotoxic substances may be the cause of up to 1 274 new cases of reproductive ill health each year, leading to an economic cost of EUR 381 million per year. **Lead** is the largest contributor to diseases from reprotoxic substances⁵⁸. The upcoming proposal for stricter binding limit values on lead will therefore be a major step forward in addressing reprotoxic substances. However, it will also be essential to **map out a specific list for key reprotoxicants to be urgently addressed**. In parallel, the **ACSH Working Party on Chemicals** will continue to discuss the need to add reprotoxic substances and hazardous medicinal products to the CMD as well as the **methodology in establishing the limit values**.

action taken: Identifying a priority list of reprotoxicants to be addressed through the relevant directives by the end of 2021.

The European Parliament and stakeholders have also stressed the need to protect healthcare staff exposed to **hazardous medicinal products** as well as other risks. The European Commission and EU-OSHA have launched extensive studies and dialogues with experts and stakeholders on how to address these risks as part of efficient healthcare provision. This has revealed a great need for further training, instruction and guidance as well as the challenges of enacting binding legislation to address this issue.

action taken: provide updated guidelines, including on training, protocols, surveillance and monitoring, for protecting workers against exposure to HMP by 2022.

SARS-CoV-2 virus was classified under the **Biological Agents Directive** under an urgency procedure.

action taken: The Commission will now monitor its implementation, as well as develop guidance for labour inspectors to help ensure the correct application of measures.

Develop guidance for labour inspectors on assessing the quality of risk assessments and risk-management measures under the **Biological Agents Directive by 2022**.

Although occupational disease is a matter closely linked to social security, which is a national competence, the Commission **Recommendation on occupational diseases** promotes the

recognition of occupational diseases listed by the Recommendation by Member States, with a view to encourage convergence.

action taken: update of the Commission Recommendation on occupational diseases to include COVID-19 by 2022.

The Commission will work with the EU-OSHA to develop supporting tools and guidance for employers to comply with occupational safety and health legislation, by addressing in particular micro and small enterprises. The Commission will call upon Member States to provide improved guidance and training for risk-assessment and prevention measures, in particular to micro-enterprises and SMEs.

The Commission calls on Member States to update and draw up their national occupational safety and health strategies in line with this strategic framework – in cooperation with social partners – to ensure that the new measures reach the workplace.

A 2023 OSH summit, gathering the EU institutions, Member States, social partners, the EU-OSHA and other relevant stakeholders, will allow taking stock of progress on this ambitious framework as well as an assessment of adaptation in light of the rapidly changing context.

5 Protocol on Ireland / Northern Ireland – Statement by the European Commission following the UK's request to extend the grace period for chilled meats [SM/ABR]

The European Commission received on the 16 June a request from the United Kingdom to extend a grace period concerning the movement of chilled meats from Great Britain to Northern Ireland, agreed within the context of the Protocol on Ireland / Northern Ireland.

This grace period is due to expire on 30 June 2021. The UK has requested that it be extended to 30 September 2021. The Commission will now assess this request.

The Commission has already indicated its openness to finding solutions in line with the Protocol.

However, for that to happen, the UK must fully implement the Protocol, which is the solution found to protect the Good Friday (Belfast) Agreement, the functioning of the all-island economy, and the integrity of the EU's Single Market. There is no alternative to the Protocol.

When looking for solutions, providing stability and predictability for the people of Northern Ireland will be of paramount importance.

Vice-President Maroš Šefčovič will reach out to Lord Frost and his team to set up a meeting as soon as possible to discuss this request in detail. The Commission will also consult the European Parliament and the Council.

According to Article 30(1)(a) of the Financial Regulation (FR), the Commission may, within its own section of the budget, decide on the transfer of appropriations within each chapter. Furthermore, according to Article 30(1)(c) of the FR the Commission may transfer operational expenditure between the chapters within the same title up to 10% of the appropriations for the financial year shown on the budget line from which transfer is made. The Commission provides to the Budgetary Authority a weekly report on the budget implementation. Most of autonomous transfers implemented during the year involve limited amounts. For the sake of transparency, this note provides detailed information on the transfers of commitment and payment appropriations autonomously implemented by the Commission in the course of 2021, in order to align the level of appropriations in the voted budget 2021 with the allocations by specific objectives agreed by the co-legislators (after the adoption of the 2021 budget) in the relevant sectoral legislation. For each programme, the transfers are by definition budgetary neutral, i.e. the sum of increases equal the sum of decreases. The programmes concerned are:

- I. Horizon Europe
- II. European Space Programme and the European Union Agency for the Space Programme (EUSPA)
- III. Erasmus+
- IV. Citizenship, Equality, Rights and Values (CERV)
- V. Justice
- VI. European Defence Fund

The Commission will keep the European Parliament and the Council informed of further possible internal transfers made in this specific context.

8.8 Opinion of a national parliament (CZ) on the Green Paper on ageing: Fostering solidarity and responsibility between generations (COM(2021)0050) [MM]

In its resolution, the Senate of the Czech Republic comes inter alia to the following conclusions:
