<sup>4</sup> Rule 143 - Motions for resolutions

1. Any Member may table a motion for a resolution on a matter falling within the spheres of activity of the European Union. That motion may not be more than 200 words long.

2. Such a motion may not:

- contain any decision on matters for which other specific procedures and competences are laid down in these Rules of Procedure, in particular Rule 47, or

- deal with the subject of ongoing proceedings in Parliament.

3. Each Member may table no more than one such motion per month.

4. The motion for a resolution shall be submitted to the President, who shall verify whether it fulfils the applicable criteria. If the President declares the motion to be admissible, he or she shall announce it in plenary and refer it to the committee responsible.

5. The committee responsible shall decide what procedure is to be followed, which may include the combination of the motion for a resolution with other motions for a resolution or with reports; the adoption of an opinion, which may take the form of a letter; or the drawing up of a report under Rule 54. The committee responsible may also decide not to follow up the motion for a resolution.

6. The authors of a motion for a resolution shall be informed of the decisions of the President, of the committee and of the Conference of Presidents.

7. The report referred to in paragraph 5 shall contain the text of the motion for a resolution.

8. Opinions in the form of a letter referred to in paragraph 5 that are addressed to other institutions of the European Union shall be forwarded to them by the President.

9. A motion for a resolution tabled in accordance with paragraph 1 may be withdrawn by its author or authors or by its first signatory before the committee responsible has decided, in accordance with paragraph 5, to draw up a report on it. Once that motion for a resolution has been thus taken over by the committee responsible, only that committee shall have the power to withdraw it. The committee responsible shall retain that power of withdrawal until the opening of the final vote in plenary.

In December 2020, given that the UK was not fully prepared for the end of the transition period – in particular regarding the import of food products from Great Britain to Northern Ireland – the EU and UK agreed a number of unilateral declarations to provide time-limited solutions in certain areas (for example, relating to the import of meat products or medicines, amongst other things).

These temporary solutions are subject to strict conditions to ensure that all relevant stakeholders are in a position to fully comply with the Protocol in the course of 2021. All stakeholders were expected to use this time effectively to adapt supply chains for chilled meats sold in Northern Ireland.

Extract from the European Commission Press statement as a reaction to the request from the United Kingdom to extend a grace period concerning the movement of chilled meats from Great Britain to Northern Ireland, agreed within the context of the Protocol on Ireland / Northern Ireland.

The grace period was due to expire on 30 June 2021. The UK has requested that it be extended to 30 September 2021. The Commission assessed the request and extended the grace period until the 30 September 2021.

#### ***1.2. Belfast High Court dismisses challenge to EU Exit Protocol [ABR/SM]***

On 30 June 2021, the Belfast High Court dismissed challenge to EU Exit Protocol

Summary of Judgment

Mr Justice Colton today dismissed two applications for judicial review challenging the EU Withdrawal Protocol and the Withdrawal Acts and Regulations. In doing so, the court said that the making of treaties and the conduct of foreign affairs are matters of high level politics which are unsuited to supervision by a court on a judicial review application. Two sets of proceedings were before the court.

Applicants: The first was the application of Jim Allister and others (“Allister”) who represented a broad range of unionist opinion in Northern Ireland. The second was brought by Clifford Peoples, a Pastor who lives in Northern Ireland, and also described himself as a unionist. There was a substantial degree of overlap between the applications.

If urgent steps are not taken to restore trust, Northern Ireland is destined to become a casualty of the post-Brexit serious deterioration in relations between the UK and the EU.”

### **LTT on a future EU-UK agreement in respect of Gibraltar**

- Spain and the UK agreed on 31 December 2020 on a framework for a UK-EU legal instrument setting out Gibraltar’s future relationship with the EU (the Framework). On this basis, Spain requested the Commission to initiate the procedure for negotiating an EU-UK agreement on Gibraltar.
- Accordingly, the Commission presented to the Council on 20 July 2021 its recommendation for opening such negotiations, with draft negotiating directives in annex.
- The Framework touches upon issues in the fields of movement of goods and circulation of persons, and **seeks to achieve the full elimination of controls and checks, including physical infrastructure, between Spain and the territory of Gibraltar.**
- The Commission’s recommendation achieves the objective of the complete elimination of controls and checks between Spain and the territory of Gibraltar, while fully preserving the integrity of the Union’s legal order and protecting the Union’s interests.
- **Checks on persons:**
  - the negotiating directives envisage that Spain, as the neighbouring Schengen state, would carry out border controls in full compliance with the Schengen acquis at Gibraltar port and airport and adjacent waters:

- in line with the Frontex regulation, Spain will be able to request Frontex assistance in implementing its obligations with regard to external border control in circumstances requiring increased technical operational assistance. In that respect, Spain has already expressed its intention to request this assistance during the initial four years period of application of the future agreement. Frontex will then organise the appropriate technical and operational assistance through joint operations, rapid border interventions and search and rescue, for border control carried out under Spain's responsibility and in its territory;
  - the negotiating directives envisage that the absence of checks between Spain and the territory of Gibraltar be compensated by a series of measures, which aim at significantly mitigating irregular migration and security risks and have an equivalent effect to various measures foreseen in the Schengen and Dublin acquis. These safeguards include, among others, rules on establishing the responsibility to examine applications for asylum, rules on return, rules on visas and residence permits, operational police cooperation and information exchange.
- **Controls on goods:**
  - the complete removal of controls and checks between Spain and the territory of Gibraltar is only possible if the future agreement sets out the necessary arrangements to protect the integrity of the Union's Single Market and Customs Union and the Union's financial interests;
  - to this end, a customs union should be established between the Union and the territory of Gibraltar and the full application of the Union acquis on the single market for goods to and in the territory of Gibraltar ensured. Anything short of that would require formalities and controls on goods crossing between the territory of Gibraltar and Spain and would not fulfil the political objective agreed by Spain and the UK.
- For provisions of Union law made applicable to the territory of Gibraltar through the future agreement, the institutions of the Union, in particular the **European Court of Justice**, should in relation to the UK (Gibraltar) and natural and legal persons established in the territory of Gibraltar, have the powers conferred on them by Union law. This is necessary to preserve the autonomy of the Union legal order.
- **Dynamic alignment** is necessary in several fields but only to the extent that is required to achieve the objectives agreed between Spain and the UK, for example in the fields of data protection, customs or indirect taxation. This addresses the very specific situation of Gibraltar and its close ties with the neighboring area.
- The negotiating directives are without prejudice to the issues of sovereignty and jurisdiction. All parties have put aside the issues of sovereignty and jurisdiction, and the focus is firmly on cooperation in the region and on the objective of having a broad and balanced agreement for the benefit of Gibraltar and the surrounding region.

### **1.5. UKCG – documents received from the European Commission [ABR/SM]**

A letter dated 26 July from European Commission Secretary General Ilze JUHANSONE to Lindsay CROISDALE-APPLEBY, Head of the UK Mission to the European Union, in reply to the UK's request of July 21 for a 'standstill' on current arrangements concerning the Protocol on Ireland / Northern Ireland

outlined in the Command Paper, is among the annexes. The request was reiterated by the Head of the UK Mission in his letter of 23 July to the Commission Secretary-General, is also among the annexes.

### **Main messages of the European Commission reply from 26 July;**

- While the EU will not renegotiate the Protocol, as many of the suggestions in the Command Paper of 21 July would require, we are ready to address issues related to the practical implementation of the Protocol and to consider any proposals, including those in the Command Paper, that respect the principles of the Protocol. We remain committed to seeking creative and flexible solutions, within the framework of the Protocol, in the interest of all communities in Northern Ireland.
- We have decided **for the moment not to move to the next stage of the infringement procedure we started in March.** We will also **not launch at this stage the request for consultations in the Joint Committee that would lead to a dispute settlement process.**
- We remain committed to seeking creative and flexible solutions, within the framework of the Protocol, in the interest of all communities in Northern Ireland.

## **2. EU-OSHA 2020 Authorising Officer's Annual Activity Report [CK]**

Based on Article 5 (1) (d) of REGULATION (EU) 2019/126 establishing the Agency and 48 (2) EU-OSHA's financial regulation, EU-OSHA presented the 2020 Annual Activity report. In 2020, the global COVID-19 pandemic has made occupational safety and health an even more relevant topic on the EU agenda. EU-OSHA has been strongly involved in the EU response to the crisis. Early on, EU-OSHA provided COVID-19 guidance for the workplace, an OiRA COVID-19 risk assessment tool along with other resources to facilitate the return to workplaces in safe and healthy conditions<sup>3</sup>. As regards the operations of EU-OSHA, the Agency was able to deliver its planned work programme almost in its entirety and at the same time to assume and deliver unplanned COVID-19 related tasks and meet its stakeholders' needs in uncertain and challenging times. This is in no small part due to the flexibility and commitment shown by the Agency's national focal points and the national tripartite networks which they operate. Besides that, EU-OSHA continued progressing towards its strategic objectives across its six priority areas. This resulted in a budget implementation of 97% and a work programme implementation of 96% (target: 90%).

## **3. Study on the evaluation of the OSH Framework Strategy 2014-2020 [CK]**

### **Agence Europe – 25 August 2021: EU's 2014-2020 framework on health and safety at work has paid off, according to a report**

The European OSH policy framework for the period 2014-2020 has had a significant and positive impact, according to a report published by the European Commission on Monday 23 August (...).

Although the particularly broad nature of the framework precludes precise data on its concrete effects, the authors note, the study found “*clear progress*” in the implementation of the seven strategic objectives, despite a slight delay of about a year (2017 instead of the originally anticipated 2016) in the realisation of some actions.

The most significant progress has been made under the first objective dedicated to the alignment of national occupational safety and health rules with the European framework. The authors believe that there is now good coherence and synergy between the national and European frameworks, although some of the people and/or entities interviewed would have liked an even more “*robust*” strategy, with even more precise objectives. Some respondents also reported a “*slight disconnect*” between the challenges identified in the European framework and the concrete actions and objectives planned. On the basis of the data and responses collected, the authors of the report recommend that the long-term objectives of the strategy should be combined with short-term action plans in the future to facilitate the operationalisation of the framework. They also recommend strengthening the resources to implement the objectives of the OSH, notably through



the *European Social Fund*. They also suggest that more attention should be paid to the emergence of atypical work statuses, but also to the consequences of climate change and possible future pandemics.

#### **4. Eurofound Consolidated annual activity report 2020 [TV]**

The six strategic areas of intervention set by Eurofound for the period 2017–2020 were:

- Working conditions and sustainable work
- Industrial relations & Labour market change
- Quality of life and public services
- The digital age: Opportunities and challenges for work and employment
- Monitoring convergence in the European Union

#### **Key achievements**

*The Living, working and COVID-19 e-survey* captured the pandemic's implications for people across Europe in two rounds in 2020 (April and July 2020) with results published the same year. The new COVID-19 EU PolicyWatch database was set up to cover measures that were introduced across EU Member States to cushion the social and economic effects on businesses, workers and citizens. The policy responses and implications were further analysed in the report COVID-19: Policy responses across Europe.

These **findings were taken up in various key EU policy documents** initiating a policy process, including the Council conclusions on Enhancing Well-being at Work of 8 June 2020, the Commission's Proposal for a Joint Employment Report 2021 the European Skills Agenda for sustainable competitiveness, social fairness and resilience, the first ever European Commission strategic Foresight Report: Charting the course towards a more resilient Europe, and the European Parliament's Report on a strong social Europe for Just Transitions.

In addition, 2020 was a year in which the discussion on minimum wages in Europe intensified. In June, Eurofound published *Minimum wages in 2020: Annual review*, which was adapted to reflect the COVID-19 crisis. In the context of the European Commission's initiative on fair minimum wages for workers in the EU, Eurofound's knowledge was reflected in 15 key policy documents from the Commission (and in particular in the proposal for a directive on adequate minimum wages in the EU), Parliament and EU social partners.

In relation to the possible EU initiative on improving the *labour conditions of platform workers*, Eurofound has provided its strong knowledge base in this area to the stakeholders. This knowledge was used, for example, to define and characterise platform work and to identify its challenges in the European Commission's Study to gather evidence on the working conditions of platform workers.

Another of Eurofound's key outputs in 2020 was the publication of the overview report of the *European Company Survey 2019: Workplace practices unlocking employee potential*, which was jointly implemented, analysed and published with the European Centre for the Development of Vocational Training (Cedefop).

## 8. Slovenian Presidency

### 8.1. *BusinessEurope's priorities for the Slovenian presidency [CK]*

In annex: BusinessEurope's priorities for the Slovenian Presidency

BusinessEurope stresses its priorities for the Slovenian Presidency in the letter to the Slovenian President. Among other points, BusinessEurope demands that European social policy must focus on facilitating job creation and equipping people with skills needed on the labour market. Recruitment is increasingly difficult for companies, even in times of high unemployment. Companies are still struggling to survive the COVID crisis. EU social policy should avoid putting additional burden on their shoulders. In the discussions on the Commission proposal for a Directive on minimum wages and collective bargaining, the Slovenian Presidency should ensure respect of the EU Treaty which protects national competences in this field and avoid heavy-handed legislative intervention regarding pay and the right of association. We remain convinced that the appropriate way to deal with minimum wages is a Council recommendation, respecting national competences and autonomy of the social partners

### 8.2. *Slovenian Presidency - informal EPSCO on 8-9 July 2021 - Agence Europe [CK]*

The European Parliament, EMPL committee, was represented by vice president Langensiepen. EU Social Policy Ministers met for 2 days in Ljubljana on Thursday 8 July and Friday 9 July to discuss the challenges of inclusiveness and labour market resilience in the face of the twin transitions of ecology and digital technology, as an economic recovery begins to pick up steam and the Covid-19 pandemic

vaccination campaigns progress.

The Commissioner for Jobs and Social Rights, Nicolas Schmit, told the press on Saturday that there was a consensus among Member States on the need to tackle the issue of youth unemployment, to address skills issues in the face of the needs generated by the double transition (and the role of lifelong learning). Mr Schmit said that the issue of gender equality had been discussed at length, in connection with the need to provide early childhood support. Furthermore, the Commissioner mentioned the National Recovery Plans, in which the social dimension is particularly present.

In a statement, the Slovenian Presidency of the Council of the EU reported a convergence of views on the importance of combating age discrimination in order to build a labour market based on intergenerational cooperation.

The ministers met their counterparts from the Western Balkans, with whom they discussed the importance of the Youth Guarantee in combating youth unemployment.

In general, the meeting seemed to confirm the momentum generated by the Porto Social Summit, but did not make a decisive contribution to future actions. There was no mention of minimum wages, digital platform workers, or even the coordination of social security systems, a diplomatic source confirmed.

## **9. Transmission of an initial appraisal of the Commission's impact assessment on improving corporate sustainability reporting [ABR]**

This EPRS Initial Appraisal provides an initial analysis of the strengths and weaknesses of the European Commission's impact assessment (IA) accompanying the above-mentioned proposal, submitted on 21 April 2021 and referred to the European Parliament's Committee on Legal Affairs (JURI). According to the EPRS Ex-Ante Impact Assessment Unit, the accompanying impact assessment (IA) provides a well-defined problem that is substantiated with evidence, a clear set of objectives that correspond to the problems identified and makes effort to cover SMEs in the consultation strategy. Overall, the evidence used in the IA seems recent and reliable. However, the IA has not set any concrete targets, indicators or timelines for achieving its objectives. The range of options in the IA appears rather imbalanced, the analysis has been predominantly economic and has focused on the effectiveness of meeting the specific objectives and their costs, while the discussion of benefits has remained rather descriptive. Environmental impacts seem to have been completely excluded, the costs of indirect effects on SMEs in the supply chains of large companies have not been quantified and the benefits for listed SMEs have not been elaborated on.

## **10. Transmission of an initial appraisal of the Commission's impact assessment on application of the equal pay principle through pay transparency measures [LS/JB]**

This EPRS Initial Appraisal provides an initial analysis of the strengths and weaknesses of the European Commission's impact assessment (IA) accompanying the proposal for a directive to strengthen the application of the principle of equal pay for equal work or work of equal value between men and women through pay transparency and enforcement mechanisms (COM(2021) 93 final). It analyses whether the principal criteria laid down in the Commission's own Better Regulation Guidelines, as well as additional factors identified by the Parliament in its Impact Assessment Handbook, appear to be met by the IA. It does not attempt to deal with the substance of the proposal.

The EPRS' Ex-Ante Impact Assessment Unit remains at the disposal of the EMPL and FEMM Committees

for any further questions or follow-up or to undertake any further IA work (in the form of a more detailed appraisal of the IA, a complementary or substitute IA or an IA of substantial amendments) which the Committees might find useful in relation to this legislative proposal.

The Strategy follows the decisions of the European institutions in 2020 to extend the European Network of Public Employment Services' mandate to 2027. The revised mandate includes the requirement to provide an EU-level instrument to stimulate national PES developments, further aligning PES activities with EU policy priorities, especially the Green Deal, the EPSR and the SDGs, to respond to labour market challenges.

The PES network will promote successful labour-market transitions by:

- Increasing capacity to enhance labour market function;

- Facilitating the supply of suitably skilled workers to promote employment growth;
- Anticipating demands, using labour market information and skills needs analysis;

- Assisting jobseekers and employers in dealing with labour market crises, by providing PES with

- support to enable them to deliver services;
- Supporting employers to adapt to their changing role in an evolving labour market;
- Optimising benefits from the evolution of the employment services ecosystem.

*17.1. COM(2021)0093 – 2021/0050(COD) – EESC opinion on the proposal for a Directive of the European Parliament and of the Council to strengthen the application of the principle of equal pay for equal work or work of equal value between men and women through pay transparency and enforcement mechanisms [LS/JB]*

On 9 June 2021, the European Economic and Social Committee (EESC) adopted its opinion on the proposal for a Directive on Binding pay transparency measures with the following conclusions and recommendations:

1.1 The EESC welcomes the Commission's proposal, which aims to make it easier for workers to enforce the principle of equal pay where they consider that they have been the victims of pay discrimination, to contribute to greater transparency in pay structures and to strengthen the role of national bodies in enforcing this principle.

1.2 The EESC notes that the proposed Directive is wide in scope, applying to all workers in both public and private sectors, and that it recognises intersectional aspects of discrimination.

1.3 However, the EESC considers that the proposal should be strengthened in various respects, particularly regarding the criteria to be used to determine the value of work, the coverage of some of the key transparency obligations, and the role of the social partners and collective bargaining in the implementation of the principle of equal pay.



1.4 The EESC considers that more detailed guidance could be provided regarding the objective criteria to be used to determine the value of work in a gender-neutral way. Such criteria should include skills and characteristics of work typically performed by women, which are otherwise often overlooked or undervalued when assessing the value of work, such as people-centred skills. These criteria should be developed with the involvement of, or by, the social partners, and formulated in a way that leaves space for further specification by them.

1.5 While the proposal is rightly sensitive to concerns about additional burdens on SMEs, the EESC does not find a complete exemption of all employers with fewer than 250 workers justified. Special rules for SMEs could, however, be appropriate. Member States should also be required to provide support, training and technical assistance to employers, particularly SMEs, with their pay transparency obligations.

1.6 The EESC considers that measures should be taken to promote collective bargaining on equal pay and other measures aimed at closing the gender pay gap, without prejudice to the autonomy of the social partners. Collective bargaining can have a significant, beneficial role in promoting equal pay and gender equality systematically at company, sectoral, regional or national levels.

1.7 The EESC points out that the measures contained in the proposal are only some of the steps necessary to address the structural issues underpinning the gender pay gap. A holistic approach that includes furthering and strengthening enforcement, will be necessary to ensure equal pay in practice. This should include further efforts to tackle labour market segregation, gender stereotypes and the undervaluation of work performed predominantly by women; adequate and accessible childcare services, as well as adequate provisions for leave for partners; and initiatives to raise awareness of pay gaps, promote career opportunities for women and ensure better representation of women in decision-making positions; and eliminating tax-related disincentives to women's employment.

The EU-UK Trade and Cooperation Agreement (TCA), which entered into force on 1 May 2021, includes provisions on the coordination of social security systems between the two parties. The Specialised Committee on Social Security Coordination ("the Specialised Committee"), which is established under Article 8(1)(p) of the TCA, can, among other things, adopt a decision amending the Annexes and Appendices to the Protocol on Social Security Coordination ("the Protocol") pursuant to Article SSC.68 thereof.

The purpose of the proposed act is to complete and correct the Annexes to the Protocol with the entries of the Member States and the United Kingdom, which were unknown at the time that the TCA was signed.

In its proposal for a Council Decision, the Commission proposes that the Council establishes the position to be adopted on behalf of the EU in the Specialised Committee on the adoption of a decision of this Specialised Committee to amend Annexes SSC-1, 3, 4, 5, 6 and 8 as well as Appendix SSCI-1 of Annex SSC-7 to the Protocol on Social Security Coordination to the TCA.

These corrections do not amend the essential elements of the Protocol.
