1. Adoption of draft agenda

The draft agenda was adopted.

2. Chair's announcements

The Chair informed about the main take-away of the joint EMPL-LIBE-PETI delegation to the Conference of State Parties on the UN Convention on the Rights of Persons with Disabilities, i.e. the need to reinforce Parliament's role in the implementation of the CRPD, possibly via the creation of a "focal point". Based on the delegation report being prepared, the Chair will make a proposal in this sense to Coordinators.

Following the CoP decision of 3 June on committee working methods post COVID, coordinators exchanged views on the topic. The decision regarding the format of committee meetings was postponed in view of the forthcoming adoption by the CCC of guidelines for hybrid modalities, and AFCO's current work on the adaptation of the Rules of Procedure.

In the meantime, committee meetings will be held in physical presence only. External experts will be allowed to connect remotely. Coordinators meetings will be held in hybrid format.

3. Points for discussion and decision

3.1. European Semester [MM]

Coordinators reconfirmed their decision of 28 April to draw up one annual report parallel to the ECON report, with a timetable to be agreed with ECON, taking into account any information that the Commission might provide on the expected timeline of the Semester process in the future.

3.2. Joint ECON-EMPL Economic Dialogue on the Spring European Semester package with the Commission [MM]

Coordinators decided to join the ECON Committee in their message to the Cabinets of EVP Dombrovskis and Commissioner Gentiloni on the disappointment about the fact that it has so far not been possible to find a slot for an Economic Dialogue. EMPL Coordinators insisted on organising a joint ECON-EMPL exchange of views on the Spring European Semester package with EVP Dombrovskis, Commissioner Gentiloni and Commissioner Schmit.

3.3. EMPL hearing on “The escalating energy poverty and housing affordability crisis” [CK/MP]

Coordinators endorsed the draft programme of the hearing.

3.4. Delegation to EU-OSHA (Bilbao), during week 38 [CK/AV]

Coordinators took note of the draft programme for the delegation and mandated the secretariat to launch a call for nomination of the participating Members.

3.5. Social climate fund: postponement of final vote in plenary

Coordinators took note of the letter from ENVI chair Pascal CANFIN informing President Metsola about ENVI's intentions to resume the vote on the Fit for 55 package, including the SCF, at the June II part-session.

4. Allocation of reports and opinions

4.1. Guidelines for the employment policies of the Member States 2022/0165 (NLE) (CK/ABR)

S&D will appoint a rapporteur. Coordinators mandated the EMPL Chair to write to the Council in order to request the extension of the deadline for the Parliament's resolution.

Coordinators decided to postpone this point to a next coordinators' meeting, once a timetable has been set by the AFCO Committee.

4.3. Commission proposal for a Directive of the European Parliament and of the Council on combating violence against women and domestic violence (COM(2022)0105)

Coordinators reconfirmed their previous decision to appoint a Rapporteur when the CoP decision on the conflict of competence is known.

Coordinators reconfirmed the previous Coordinators decision to appoint a Rapporteur only when the CoP decision on the conflict of competence is known and took note of the update of the Chair regarding this conflict of competence.
