## **1. Adoption of draft agenda**

*The agenda was adopted without changes.*

## **2. Points for discussion and decision**

### **2.1. Programme of Hearings – 2023 – 1st Semester [CKS]**

- *Coordinators approved the following hearings:*
  - a) *Social and employment consequences of the rising cost of living*

- b) *Future-proof jobs and skills training for the digital and green transitions.*
- c) *Working conditions of firefighters*
- *Coordinators also decided to hold an exchange of views on Youth unemployment, in particular in outermost regions.*

## **2.2. Programme of missions and delegations - 2023 - 1st Semester [TV/KS]**

- *Coordinators decided on the following missions and delegations:*
  - a) *a mission to Spain, in week 20 (possibly 15-17 May)*
  - b) *a mission to ELA, possibly in week 8 (possibly 20-21 February)*
  - c) *an ad hoc delegation to the UNCRPD in June, led by EMPL, in the 2022 format*
- *Coordinators could agree on an additional delegation at a later stage.*

## **2.3. Programme of activities with National Parliaments – 2022 Second Semester and 2023 - 1st Semester [TV]**

- *Coordinators approved a meeting with National Parliaments in June, to celebrate two years of the Child Guarantee.*
- *Coordinators agreed to hold a meeting with National Parliaments and competent committees AFCO and PETI on the participation of disabled persons in the electoral process in the second semester of 2023.*

## **2.4. Minimum income [ABR]**

- *Coordinators decided to draft an oral question and a Resolution on Minimum income. The Greens/EFA group will take the lead on the MfR.*
- *Coordinators also decided to agree whether to draw-up an oral question and a resolution on the forthcoming Commission proposal on Social dialogue. Depending on the publication date of the proposal, which is still to be confirmed, this item will be decided in the next Coordinators' meeting or by written procedure.*

## **2.5. Hearing on Uber [KS/NM]**

- *Coordinators agreed on a hearing to be held on 25 October on:*
  - “The Uber’ files, lobbying, and workers’ rights”*
- *Coordinators decided to invite Mark McGann, former Uber lobbyist and whistleblower*
  - The secretariat will circulate a call for speakers, based on the agreed revised concept note (change of title, deletion of paragraphs 3, 4 and 5)*

## **2.6. EMPL event during Gender equality week**

- *In the framework of the Gender Equality Week, coordinators decided to organise an exchange of views with EIGE on the Care Strategy (EMPL meeting of 24 - 25 October).*

## **2.7. New STOA study on ‘Artificial intelligence and digital tools in workplace management and evaluation: An assessment of the EU's legal framework’ [HH]**

- *Coordinators decided to have a presentation of the study in the EMPL Committee, separately from the hearing on digital and green transition.*

## **2.8. Parliamentary committees’ scrutiny of the implementation of the UK Withdrawal agreement (WA) and the EU-UK Trade and Cooperation Agreement (TCA)**

- *Coordinators took note of the proposal on the division of competences and mandated the Chair to request exclusive competence for EMPL on relevant parts of chapter 7.1 Labour and social standards, environment and climate, sustainable development;*
