**2. Chair's announcements**

### **3. Points for discussion and decision**

#### **3.1. Preparation of EMPL ICM in Parliamentary Week (27-28 February 2023)**

*Coordinators decided to propose the following as themes for the ICM meetings:*

- The deteriorating and uncertain economic situation with high energy prices and high inflation - a discussion of the present situation, socio-economic consequences (including for the labour market and competitiveness, including small and medium enterprises), remedies and what can be expected in the future
- Lessons learned from the pandemic on working conditions for cross border workers combined with the issue of teleworking conditions for cross-border workers and how to ensure social security rules are better adapted to new developments on telework and other hybrid forms of work

*Additionally, as the programme design is in a very early stage and some EMPL proposals might for ICM might become plenary topics, coordinators decided about additional ICM priority topics in order of preference:*

- Further integrating the social dimension in the review of the EU's economic and fiscal framework.
- EU support to Ukrainian refugees and solidarity with the EU Members and other countries (including Moldova) providing support to Ukrainian citizens.

#### **3.2. Conflict of competence on INI report on integrated child policies - update and way forward**

*Coordinators decided not to endorse the draft letter and proceed with this INI request independently of the FEMM and CULT objections and accept possibly CCC direct compromise solution. A new title for this report will be proposed.*

#### **3.3. Hearing of a candidate to the post of the Director of the European Training Foundation**

*Coordinators decided the hearing should be organised as soon as possible, possibly on 12 January 2023.*

#### **3.4. Relations with the Committee on Social Policy and Protection of Veterans' Rights of Verkhovna Rada of Ukraine**

*Coordinators mandated the Chair to send a reply letter to Verkhovna Rada, in line with a general approach at committee level.*

#### **3.5. Follow-up to the Porto Social Summit**

*Coordinators decided on a three-step approach:*

- Letter to Swedish Presidency and Minister, followed by:
- A letter to the Portuguese Minister in view of the 2-year anniversary event.

- *A letter to the Yolanda Díaz Pérez Spanish Second Vice-President of the Government of Spain and Minister for Work and Social Economy.*
