#### 2. Points for discussion and decision

##### 2.1. Planning of Hearings - Missions – Activities with National Parliaments - second semester 2023

###### A. VISITS TO AGENCIES

- *The coordinators decided to visit CEDEFOP in the second semester of 2023 and ETF at the beginning of 2024.*

## **B. MISSIONS INSIDE THE EU**

- *Coordinators decided on the following missions.*
  - *Hors quota visit to Belgium.*
  - *Germany and Poland on the working conditions and worker's rights in Amazon warehouses (after Parliamentary elections in Poland).*

## **C. PUBLIC HEARINGS**

- *The coordinators held an exchange of views o hearings for the second semester of 2023. The following hearings received the broadest support:*
  1. *The social impact of public procurement (incl. sub-contactors) – can the EU do more?*
  2. *Algorithmic management.*
  3. *Labour shortages and jobs of the future.*
  4. *Social and labour market integration of Roma people from settlements - good practices and lessons learnt from the Member States*
- *In case the number of paid experts exceeds the annual quota of 16, the last topic will be organised in the form of an exchange of views with non-paid experts.*

## **D. ACTIVITIES WITH NATIONAL PARLIAMENTS**

- *Coordinators confirmed their decision of 8 September 2022, to hold a meeting with national parliaments and competent committees - AFCO and PETI - on the participation of disabled persons in the electoral process in the second semester of 2023.*

### **2.2. Agencies – Renewal of mandate of independent experts appointed by EP to Agencies’ Management/Governing Boards**

- *Coordinators agreed to launch a written procedure inviting each group to present one candidate for each of the four posts of independent experts appointed by Parliament to the Management Boards of Cedefop, EU-OSHA, Eurofound and ELA “offering the qualifications required by the regulation establishing the agency or body and holding the nationality of one of the Member States”. The deadline for presenting such candidacies would be 15 April 2023.*
- *Coordinators further agreed to select one candidate per post, without organising a public hearing. The final decision on the four experts recommended to CoP will be made at Coordinators’ level.*

### **2.3. Joint CULT-EMPL INL on an EU framework for artists and creative workers**

- *The coordinators mandated the Chair to negotiate further on the conflict of competence, with the aim to keep the INL title as open as possible while agreeing not to touch upon JURI’s competences.*

### **2.4. Guidelines and EMPL Practices on the preparation and conduct of votes**

- *Coordinators endorsed the document, with the opposition of the S&D.*
