**1. Adoption of draft agenda**

- *Coordinators discussed EMPL hearings and exchanges of views planned for the rest of the year in view of ensuring best attendance of Members. Coordinators decided to:*
  - o *Cancel the exchange of views with Ms Diamantopoulou planned on 24 May.*
  - o *Explore possibilities to ensure a minimum presence of Members at events with external speakers.*
  - o *Revisit the list of events planned until the end of 2023 at a future coordinators meeting.*

**2. Points for discussion and decision**

**2.1. Agencies – Renewal of mandate of independent experts appointed by the EP to Agencies' Management Boards**

- *Coordinators decided to extend the deadline for the nomination of candidates for experts for all agencies, with a view to ideally reaching a decision (i.e. recommendation to the CoP) at the latest before the summer break.*

**2.2. Presentation of ECA special report on SURE**

- *Coordinators decided to invite the ECA author for a presentation of the special report, when the publication of the European Commission assessment is available.*

**2.3. Disability Rights Week**

- *Coordinators decided to organise a Disability Rights Week during week 48 – 49, 27 November – 4 December, and to mandate the Chair to write to Committee Chairs and the EP President in this respect.*

- *Coordinators also agreed that the EMPL ICM with AFCO and the hearing with FEMM, will be organised during this week and mandated the Chair/secretariat to liaise with the respective secretariats regarding the date of the events.*

#### **2.4. Identification of future research products**

- *Coordinators decided that future EMPL research products will be agreed by coordinators on the basis of an exercise, to be prepared by the secretariat and poldep, to look into more forward-looking studies for the next legislature.*
