1. Allocation of reports and opinions

1.1. Legislative Opinions

1.1.1. Proposal for a regulation of the European Parliament and of the Council establishing an EU Talent Pool ([COM\(2023\)0716](#) - 2023/0404 (COD))

- *Coordinators allocated the opinion to S&D.*

2. The Future of the EU Social Agenda – La Hulpe process. The Inter-institutional declaration content and process

- *Coordinators endorsed the following steps in the preparation of EMPL input to the Inter-institutional Declaration and La Hulpe process:*

- *request President Metsola to mandate the EMPL Committee to design the EP input to the Inter-institutional Declaration;*
- *prepare written input to the Declaration in the form of: (a) a cover letter containing 5-6 main priorities for the future of the EU Social Agenda, and (b) an annex to the letter – revised ‘Summary or proposals of the EMPL Committee on the future of the EU Social Agenda – La Hulpe process’;*
- *request the Belgian Ministers coming to the EMPL Committee to present their expectations in relation to the EMPL input to the Inter-institutional Declaration and La Hulpe process;*
- *schedule a meeting between EMPL Coordinators and Belgian Presidency once the first draft of the Inter-institutional Declaration is ready.*
- *Coordinators agreed to prepare the consolidated EMPL input (letter and annex) to the Inter-institutional Declaration in a written procedure, to be followed by discussion and approval by the Coordinators, by the end of February 2024 at the latest.*

3. Coordination of Social Security Systems

- *Coordinators held an exchange of views with the Rapporteur Gabriele Bischoff (S&D).*
- *Coordinators endorsed Rapporteur’s recommendation according to which the Chair is mandated to write together with the Rapporteur, on behalf of the committee, to the Belgian Presidency indicating that Parliament cannot accept a decoupling of the provisions of the revision of the Social Security Regulation as the revision is a well-balanced package.*
- *Coordinators mandated the EMPL Secretariat to start administrative preparations for a possible adoption of Parliament’s first reading position, but to leave the decision on how to proceed to the Rapporteur and negotiating team following discussions with the Belgian Presidency and to inform the Coordinators of negotiating team’s decision on the way forward in writing.*

4. Equality bodies proposals (2022/0400(COD) and 2022/0401(APP)): next steps

- *Coordinators agreed to send a joint EMPL, LIBE & FEMM Chairs’ letter to the CCC to state the three Committees’ wish not to raise a conflict on the consent file, and decided not to issue an opinion on this file, without prejudging future possible reopening of the competence issue on this topic.*
- *Coordinators agreed to exceptionally work in EN only in order to adopt the report in the shortest possible time, if the file is referred to EMPL.*

5. EMPL input to the ECA Work Programme 2025

- *Coordinators decided to submit on behalf of EMPL the following suggestions for the ECA work programme 2025+:*
 1. *EU support for the integration of Roma children – an analysis of the targeting, use and impact of the EU money,*
 2. *The integration of young people not in employment, education or training (NEETs) in the labour market, including through vocational education and training - an analysis of the use of EU funding in the area,*
 3. *Strategies for older persons - an analysis of use of the EU funding for preventing the age discrimination.*

6. EMPL end-of-term reflection session

- *Coordinators provisionally endorsed, with comments, the proposed concept for the end of term reflection session, including the main topics and choreographies to address them, and decided to prepare the programme of the session in a written procedure.*

7. Follow up of the 1st EP “Disability Rights Week” (DRW)

- *Coordinators shared their political evaluation of the 1st EP DRW, and agreed to continue organising DRWs in the future order to be able to already start administrative preparations for the 2024 DRW (subject to final confirmation at the beginning of the next term).*

8. Petitions

8.1. Received for opinion

8.1.1. Petition No 0924/2023 by M. G. (Irish) on fair wages for garment and footwear sector employees

- *Coordinators decided not to draw up an opinion.*

8.1.2. Petition No 0742/2023 by Tomás Cobo Castro (Spanish), on behalf of the ‘Consejo General de Colegios Oficiales de Médicos’ (General Council of Official Doctors’ Associations), on the working conditions of doctors in the public health service in the autonomous cities of Ceuta and Melilla (Spain)

- *Coordinators decided not to draw up an opinion.*

8.2.1. Petition No 0736/2023 by I. A. (German) on protection against bullying in the workplace

8.2.2. Petition No 0780/2023 by Fotios Batzios (Greek) on workers' rights in Greece

- *Coordinators took note of the above-mentioned petitions.*

9. Recommendation of the EU-UK Parliamentary Partnership Assembly on youth mobility schemes, student exchanges, school trips and touring artists

- *Coordinators decided to send any observations or comments to the recommendation, to be prepared in a written procedure, in the form of a letter from the EMPL Chair to the D-UK Chair.*

11. Any other business

11.1. Follow-up to the EoV on working conditions in the Amazon warehouses

- *Coordinators decided, following repeated refusal of Amazon to attend EMPL hearings, to: (a) task the secretariat to gather information on the procedure to request Parliament authorities and governing bodies to withdraw access badges to Parliament's premises, and report back to Coordinators, and (b) send a letter to President Metsola to that effect in respect of Amazon representatives.*

11.2. Forthcoming revision of the European Works Council Directive

- *Coordinators decided to start the examination of the Commission proposal on the revision of the European Works Council Directive in a speedy manner, and to decide on the procedure to be followed after the proposal has been presented.*
