Recital 3

Text proposed by the Commission

(3) Directive 2007/2/EC⁵ of the European Parliament and of the Council lays down general rules aimed at the establishment of the Infrastructure for Spatial Information, for the purposes of Union environmental policies and policies or activities which may have an impact on the environment. Article 21(2) of that Directive requires Members State to **update, if necessary, and** publish a report including, among other things, a summary description of the costs and benefits of implementing that Directive **by 31 March of each year**.

Amendment

(3) Directive 2007/2/EC⁵ of the European Parliament and of the Council lays down general rules aimed at the establishment of the Infrastructure for Spatial Information **in Europe (INSPIRE)** for the purposes of environmental policies of the Union and policies or activities which may have an impact on the environment. Article 21(2) of that Directive requires Members State, **by 31 March of each year**, to publish a report, **updated if necessary**, including, among other things, a summary description of the costs and benefits of implementing that Directive.

Article 1 – paragraph 1
Directive 2007/2/EC.

‘**No later than 31 March every** two years, starting from 31 March 2025, Member States shall **update, if necessary, a** summary report. Those reports, which shall be made public by the Commission services, shall include summary descriptions of:’.

‘**Every** two years, **no later than 31 March**, starting from 31 March 2025, Member States shall **draft an updated** summary report. Those reports, which shall be made public by the Commission services, shall include summary descriptions of:’.
