▪ *Fuel Quality Directive Comitology measure - tar sands*

The chairman informed the Members that on the 23 February 2012, the Standing Committee on Fuel Quality was unable to adopt a favourable opinion on the proposed Commission measure which would establish calculation methods and reporting requirements relating to the greenhouse gas intensity of certain fuels. The draft measure proposes in particular, a default value for tar sands. The vote in the Committee (weighted according to the relative size of the 27 Member States) was as follows: 89 in favour; 128 against; 128 abstentions.

The qualified majority necessary to enable the Committee to adopt a favourable opinion (255) was therefore not reached. Under the Comitology Decision, the Commission will in the coming months make a proposal for a Council Directive, which is also forwarded to the European Parliament for scrutiny. Committee Members will be notified of this in due course via the ENVI Comitology newsletter

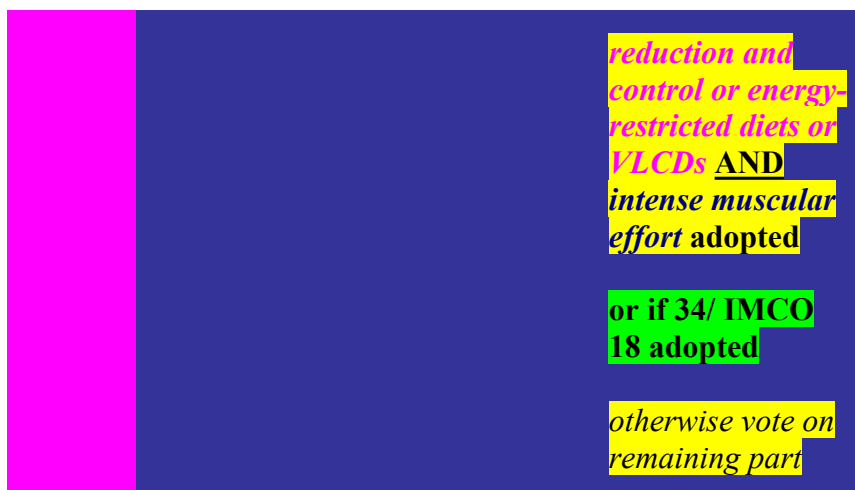
