#### 3. DECISIONS ON URGENT MATTERS

3.1 Speakers for the public hearing on "Reducing Greenhouse gas emissions from EU-related maritime transport: what's next after the EU MRV?" (SD/IP)

Decision taken:

Coordinators mandated the secretariat to prepare an agreement together with the political group staff on the four speakers and two substitutes and to finalize the procedure by written procedure in the coming days.

3.2 Mission to COP15 to the Convention on Biological Diversity (CBD) in Kunming (China) - October 2020 (ES)

**Decision taken:** 

Coordinators decided to request authorisation on an exceptional basis from the Conference of Presidents for sending an ad hoc ENVI delegation consisting of 12 Members to the high-level segment of the CBD COP15 Climate Change Conference in Kunming, China from 28 October to 1 November 2020 in view of the exceptional relevance of the conference.

3.3 Composition of ENVI delegation to EFSA, 24-25 February 2020 (ES/NH)

**Decision taken:** 

Coordinators mandated the ENVI Chair to inform the Conference of Committee Chairs of an ENVI delegation consisting of 3 Members to EFSA, 24-25 February 2020.

Coordinators decided to set a deadline for 16 December 2019, close of business, for political groups to submit to the secretariat the names of their Members participating (1 EPP, 1 S&D and 1 Renew).

3.4 Composition of the ENVI delegation to IMO MEPC 75 in London, 30 March - 3 April 2020 (IP/SD)

Decision taken:

Coordinators mandated the ENVI Chair to inform the Conference of Committee Chairs of an ENVI delegation consisting of 3 Members and the Chair to IMO MEPC 75 in London, 30 March - 3 April 2020.

Coordinators decided to request, as it was done for previous missions, that the Policy Department commissions a briefing on the key issues at stake in view of the IMO MEPC 75.

Coordinators decided to set a deadline for 16 December 2019, close of business, for political groups to submit to the secretariat the names of their Members participating (1 EPP, 1 S&D and 1 Renew).

3.5 Composition of the ENVI delegation to ECDC, 6-7 April 2020 (SC/IP)

Decision taken:

Coordinators mandated the ENVI Chair to inform the Conference of Committee Chairs of an ENVI delegation consisting of 3 Members to ECDC, 6-7 April 2020.

Coordinators decided to set a deadline for 16 December 2019, close of business, for political groups to submit to the secretariat the names of their Members participating (1 EPP, 1 S&D and 1 ECR).

3.6 EP delegation to COP26 in Glasgow, November 2020 (ES/SC)

**Decision taken:** 

As in previous years and in order to secure accommodation for the participants, Coordinators decided to request authorisation, jointly with ITRE, from the Conference of Presidents for sending an ad hoc EP delegation consisting of 15 Members to participate in the high-level segment of the COP26 Climate Change Conference in Glasgow, November 2020.

**Decision taken:** 

Coordinators mandated the Chair to send a letter to the AGRI Chair, reminding AGRI from a procedural point of view about the delimitation of competences as laid down in the Rules of Procedure and pointing to the specific part of the AGRI report amending aspects of the proposal under ENVI competence.

- B. Joint BUDG-ENVI hearing on "Greening the budget: how to upgrade climate and biodiversity mainstreaming and to improve the tracking of related budget expenditure. Which role for 'green own resources'"? (GR)
- <u>Decision taken:</u> ENVI coordinators mandated the Chair to discuss with the BUDG Chair the detailed programme and date of the hearing and to report back to coordinators afterwards.
- C. TRAN INI on technical and operational measures for more efficient and cleaner maritime transport

They stressed the importance to ensure that the report will only touch on issues under the competences of the TRAN committee, as highlighted in the authorisation request.

- 1. Motion for a resolution on the bed bug scourge in Europe by Joëlle Mélin B9-0165/2019

7.2 Petitions for opinion (NP)

Petition No 1078/2018 by Velichka Velichkova (Bulgarian), bearing 182 signatures, on the violation of the environmental legislation at a biogas plant in Tsarevets village, Mezdra Municipality, Bulgaria. The petitioner complains that the biogas plant in Tsarevets village, which processes about 164 tons of waste daily, does not comply with EU law. It is alleged that during the planning and the construction of the plant, the requirements for environmental protection have not been complied with and that a public health impact assessment has been deliberately avoided.

Petition No 1091/2018 by Galina Tosheva (Bulgarian), bearing 595 signatures, on the request for decommissioning the biomass plant in Trud, Bulgaria. The petitioner complains about the construction of a biomass plant close to a residential area near Trud, Bulgaria. It has been alleged that the construction of the plant does not comply with EU laws on health and environmental protection, thus causing noise, air pollution and potential health risks.

Petition No 1105/2018 by Kremena Petrova (Bulgarian), on behalf of the Association "Nova Zagora wants to breathe" ("Нова Загора иска да диша"), bearing 1176 signatures, on a biogas production plant in Nova Zagora, Bulgaria. The petitioner complains that the construction of the biogas plant in the town of Nova Zagora does not comply with EU Directives and Regulations on health and environmental protection. The petitioner points that this has had a largely negative impact on environmental pollution as well as the health of the citizens.

Proposed decision: No opinion. The Chair will reply accordingly to the PETI Chair.

7.3 ENVI Priorities for the 2021 work programme of the European Court of Auditors (GR)

As every year, the European Court of Auditors (ECA) wishes to consult all the Parliament's Committees for its work programme (this year, for 2021), via the Conference of Committee Chairs (CCC). ENVI should send its proposals to the CCC by 14 February 2020.

Last year, ENVI put forward the following topics for ECA's 2020 Work Programme:

- 1. Assessment of the implementation of the Falsified Medicines Directive (Directive 2011/62/EU) and Commission Delegated Regulation (EU) 2016/161. Recommendation to audit the implementation of the Falsified Medicines Directive and subsequent legislation as it will apply as of 9th February 2019, in particular the implementation and information to the public on common pharmacy logo for online pharmacies, the safety features of medicines and functioning of the serial number of medicine packages (data protection and effective safety assurance for patients in all healthcare settings mainly hospitals).
- 2. Assessment of the implementation of the 2020 EU Biodiversity Strategy, in particular the mobilisation of (Union and Member States) resources, the functioning of the Common Implementation Framework, the integration into sectoral policies, as well as the other measures necessary for reaching the headline target and the six targets of the strategy, taking into account the degree of success in reaching these targets. The Biodiversity Strategy is the overarching framework for biodiversity policy in Europe and stems from commitments made by EU leaders in March 2010. It is also based on the international commitments adopted by 193 countries, including the EU and all its Member States, at the conference of the Parties to the Convention on Biological Diversity in Nagoya, Japan, in 2010.

#### ECA's 2020 Work Programme was published on 30 October 2019<sup>1</sup>.

In 2020, the Court expects to publish 41 reports, why are selected based on an assessment of the main risks in relation to EU spending and policy delivery. For the first time, ECA will also publish an annual report on the performance of EU policies. Furthermore, the Court is planning individual audits to analyse whether the EU is properly addressing climate change, with reports on pesticides use and plastic waste, as well as on the marine environment, biodiversity in farming and pollinators, among other topics. The Court will also consider the UN's Sustainable Development Goals, covering all but 3 of these 17 goals next year.

It does not include ENVI's proposals, despite the fact that they were included in the CCC list.

### 8.2 Petitions for information (NP)

- Petition No **0401/2019** by S.S.L. (Spanish), on behalf of the association 'Plataforma Toledo Aire Limpio', on the need for a change in the European Union's energy and environmental policy on waste treatment and management. The petitioner wants to see energy and environmental policy on waste treatment and waste management changed to stop the harmful effects caused by waste incineration, as has happened, he believes, in La Sagra (Toledo). He says La Sagra suffers from extremely heavy pollution emanating from two big cement works located in the area. The petitioner also reports that plants manufacturing the liquor orujo in the olive-growing region of Toledo produce emissions and send out a greasy smoke into the air which permeates local homes and causes local residents breathing problems. The petitioner considers there is considerable discrepancy between what the EU stipulates in its environmental legislation and what actually happens on the ground, as can be seen in the circular economy in the Autonomous Community of Castile La Mancha.
- Petition No **0560/2019** by Timothée Galvaire (French), on behalf of Fairosene, on the introduction of a tax on aviation fuel (kerosene) for flights within the Union The petitioner requests that the European Union consider the application of a tax on aviation fuel for flights within the EU. The petitioner states that the aviation sector enjoys numerous tax advantages despite being one of the largest contributors to greenhouse gas emissions. The petitioner points out that other more environmentally friendly alternatives are subject to high taxes while Member States do not charge VAT on airline tickets.

### 8.5 Documents recently published by the European Court of Auditors

The following documents were recently published:

#### SPECIAL REPORTS

Special report No 16/2019 on European Environmental Accounts (EEEA): usefulness for policy makers can be improved (10 October 2019) (the first report has been postponed from coordinators' meeting of 25/11)

The EEEA are a statistical framework consisting of a comprehensive set of tables and accounts describing the relationship between the environment and the EU economy. The Court audited whether the Commission set up, managed and used the EEEA well. The report shows that the Commission did not set out a long-term perspective for EEEA data needs for environmental

policymaking. The Commission did not compile EEEA needs, nor detailed which indicators are needed. While there is a strategy for the EEEA, a comprehensive action plan to implement the objectives is missing. The Court also found that the Commission implemented EEEA modules without a full cost-benefit analysis and that the EEEA modules were not used to their full potential for monitoring key environmental policies. Although the Commission published some data earlier than required, it did not exploit all means of providing data more quickly. There is no release calendar to indicate when data becomes available. The Court recommends that the Commission should improve the strategic framework for EEEA data, the relevance of EEEA modules for environmental policy making and the timeliness of EEEA data.

# Special report No 16/2019 on EU greenhouse gas emissions: well reported, but better insight needed into future reductions (20 November 2019)

The Commission is responsible for reviewing the data reported by Member States on the current and projected emissions and for proposing EU policies and measures to reach the reduction targets. The audit focused on efforts of the Commission, assisted by the European Environment Agency, to ensure the quality of the EU greenhouse gas inventory and of the information on future emission reductions. The Court found that EU greenhouse gas emissions data is reported in line with international requirements and inventories of emissions have improved over time. However, better insight is needed into specific sectors such as agriculture and LULUCF. They also suggest further improvements to reporting on how EU and national mitigation policies contribute to meeting emission reduction targets for 2020, 2030 and 2050.

Based on its findings, the Court makes also recommendations to the Commission aimed at improving the Commission review process for the LULUCF sector and the framework for future emission reductions.

# Special report No 21/2019 on addressing antimicrobial resistance (AMR): progress in the animal sector, but this health treat remains a challenge for the EU) (15 November 2019)

The Court assessed the European Commission's and EU agencies' management of key activities and resources to reduce AMR, examined the Commission's support for the Member States' 'One Health' response and its contribution to promoting the prudent use of antimicrobials in animals, and looked at EU support for AMR research. The Court concluded that EU support to strengthen Member States' 'One Health' approaches to AMR contributed to better-informed policy decisions and facilitated cooperation and exchange of experience between Member States. However, there is potential for further synergies to support the fight against AMR through targeted, cost-effective investments. The Court pointed out gaps in the monitoring of progress and surveillance of healthcare-associated infections, which is likely to slow down actions against AMR and considers that scientific data on the occurrence and spread of AMR in the environment remains insufficient. While progress was uneven, the use of veterinary antimicrobials had become more prudent in most EU Member States. Nevertheless, use of some antimicrobials is still too high. New EU rules for veterinary medicinal products and medicated feed address some of the known weaknesses. However, some issues remain, such as the difficulties Member States face in collecting data and gaps in the monitoring of resistant bacteria in food and animals. The EU budget is a major source of funding for investment in AMR research. However, there has not yet been any breakthrough in the development of new classes of antimicrobials.

Based on its findings, the Court recommends to improve the EU's response to AMR, in particular by enhancing support to Member States, promoting prudent use of veterinary antimicrobials and better monitoring of AMR and strengthening strategies for boosting AMR research in the EU.

**Special reports** present the results of selected audits (performance audits) on specific policy or spending areas, or on budgetary or management issues.

**Annual reports** mainly contain the results of financial and compliance audit work on the EU budget and the European Development Funds, but also budgetary management and performance aspects.

**Specific annual reports**, published separately on the EU's agencies, decentralised bodies and joint undertakings.

**Opinions** on new or updated laws with a significant impact on financial management, either mandatory under the TFEU, at the request of another institution or on our own initiative.

Briefing papers describe and analyse policy or management, focusing on specific topics.

**Landscape reviews**, similar to briefing papers, but focused on complex, large-scale policy areas or management issues, often from a cross-cutting perspective.

Rapid case reviews establish facts surrounding very focused specific issues or problems.

Audit previews present background information on a forthcoming or ongoing audit.
