

(2) The European Union has been providing development cooperation aid since 1957 and is the largest donor of official development aid in the world.

Rape and other forms of sexual violence are perpetrated in many contexts and are also increasingly used as a tactic of war to humiliate and dominate.

Amendment 6

Proposal for a decision Recital 5

Text proposed by the Commission

(5) The fight against poverty remains the primary objective of the European Union's development policy, as laid down in Article 21 of the Treaty on European Union and Article 208 of the Treaty on the Functioning of the European Union.

Amendment

(5) The fight against poverty and all forms of discrimination on the basis of sexual orientation, gender identity or gender expression should be the primary objective of the European Union's development policy. The allocation of financial development aid should be subject to the upholding of these universal values.


