FEMM-utskottets samordnare beslutade vid sitt sammanträde den 24 maj 2023 att

- godkänna FEMM-utskottets tio huvudbudskap,
- begära ett gemensamt utskottsförfarande med LIBE för översynen av direktivet om brottsoffers rättigheter,
- anordna ett gemensamt sammanträde den 5 juni med LIBE-utskottet om översynen av direktivet mot människohandel i hybridform – fysiskt och med möjlighet för ledamöterna att delta på distans,

- lägga fram ändringsförslagen till förslaget till yttrande över budgetresolutionen för 2024 endast på engelska och att arbeta med budgetändringsförslagen endast på engelska,
- ge utredningsavdelningen i uppdrag att utarbeta en briefing om de nationella parlamentens praxis när det gäller jämställdhetsbudgetering, i samarbete med CONT- och BUDG-utskotten,
- godkänna anordnandet av en diskussion om jämställdhetsintegrering i EU:s budget tillsammans med BUDG- och CONT-utskotten, och bjuda in de förtecknade organisationerna samt kommissionsledamot Hahn. Dessutom beslutade man att se till att lokal och regional budgetering också tas upp i denna diskussion, som även ska läggas fram för BUDG- och CONT-utskotten för godkännande,
- att låta FEMM-utskottet delta i kvinnoforumet inom ramen för den gemensamma AKS-EU-församlingen,
- att godkänna det uppdaterade programmet för FEMM-utskottets delegation till Bogota (Colombia),
- att den nya titeln på den sammanslagna studien från FEMM-utskottets forskningsprogram ska vara *Könsrelaterade aspekter av sexuell och reproduktiv hälsa: adekvat screening, behandling och forskning, inklusive fertilitet, endometrios, HPV och toxic shock syndrome i EU:s medlemsstater*

I det skriftliga förfarandet av den 5 juni 2023 enades FEMM-utskottets samordnare om att EMPL- och FEMM-utskottens ordförande skulle skicka en skrivelse till rådets ordförandeskap med en uppmaning till rådet att inte begära parlamentets godkännande för utkastet till rådets direktiv om standarder för likabehandlingsorgan förrän de interinstitutionella förhandlingarna om det förslag till direktiv som behandlas inom ramen för medbeslutandeförfarandet har slutförts, för att inte äventyra parlamentets befogenheter och för att samtidigt få två sammanhängande texter.
