- that the topic for IWD ICM 2026 will be: Women's Rights and Democracy: Combating Stereotypes, Disinformation and Violence in the Digital Age;
- to organise an exchange of views with UNFPA;
- regarding hearings on Digital Violence and Women's Mental Health and Menopause Care in the EU, FEMM coordinators did not agree with the SANT proposal and wish the hearings to consist of fully joint panels.
