Summary of Coordinators recommendations

A. Chair's announcements

The Chair informed the Coordinators that a report of the FISC mission to Paris on 24 February 2022 will be circulated by the Secretariat.

B. Public hearings and exchanges of views until the summer break

The Coordinators endorsed the following public hearings and exchanges of views until the summer break.

- Tuesday, 10 May, 13.45 to 15.45: "***The use of special tax regimes in the EU by high net worth individuals: the case of Russian oligarchs***" – *workstream 2 (Pandora Papers)*

In addition, the Secretariat was tasked to provide a briefing (possibly prepared by EPRS or PolDep) with relevant information and data on the issue.

- Tuesday, 10 May, 16.45 to 18.00: **Exchange of views with government's representatives of the British Virgin Islands or other relevant jurisdictions** – *workstream 2*
- Thursday, 16 June, 9.00 to 11:30: "*Case studies on member states national tax policies - **Ireland**: implemented national tax reforms and*

the combat against aggressive tax schemes” – workstream 1 (reform of the corporate tax system).

- Monday, 27 June, 13.45 to 15.00: Exchange of views with **Commissioner Gentiloni**: *“The evaluation of the political and legislative follow-up to the works of the FISC Subcommittee”*
- Monday 27 June, 16:45-18:45: Presentation of the two **studies** on :
 - *“Removal of taxation-based obstacles and distortions in the Single Market in order to encourage cross border investment” – workstream 1;*
 - *“The regulation intermediaries, including tax advisors, in the EU/Member States and best practices from inside and outside the EU” – workstream 2.*
- Thursday 13 July, 13:45-16:15: *“The role of **tax incentives and exemptions in the framework of the reform of corporate taxation and in the promotion of European economies competitiveness**” – workstream 1*

In addition, the Coordinators discussed the possibility of inviting an expert of the Commission to explain the proposal made in the REpowerEU Communication as regards potential national taxes on windfall profits.

Political groups were invited to provide the Secretariat with suggestions for invited speakers for each of the hearings.

C. FISC Working programme for the 2nd half of 2022

1. Public hearings:

The Coordinators decided to request authorisation to the CCC/CoP for the following hearings:

- **“The work of national tax authorities: resources, strategies, cooperation”** (September tbc) – *workstream 2.*
- **Exchange of views with Marnix van Rij, Dutch State Secretary for Tax Affairs and Tax Administration** (September tbc) – *workstream 1.*

- **"The Reform of Corporate Taxation: what's next?";** this hearing would focus on the implementation of the Pillar 1 of the OECD agreement and on the how to make the design of the future EU tax rulebook (BEFIT) a success (October tbc) – workstream 1.
- *"Case studies on member states national tax policies - **Luxembourg**: implemented national tax reforms and the combat against aggressive tax schemes"* (October tbc) – workstream 1.
- *"Case studies on member states national tax policies - **Germany**: implemented national tax reforms and the combat against aggressive tax schemes"* – workstream 2 (November tbc).
- **"Potential Distortions of the Single Market due to Personal Income Tax: challenges for SMEs and risks of harmful tax competition"** (December tbc) – workstream 2.

In the first part of the hearing, experts will be invited to examine what are the biggest challenges for SME's in the tax area due to taxation divergences within the EU. In the second part of the hearing, experts will be invited to examine whether harmful tax practices are emerging in the area of personal income taxation.

2. Activities with National Parliaments

The Coordinators agreed to organise a bilateral meeting with the Czech Parliament in 2022 and with the Swedish Parliament in early 2023.

Any other meetings with National Parliaments should be linked to missions and included in related programmes.

3. Missions

The Coordinators agreed to request authorisation for the following missions:

Ireland (date: week 29 in July).

Number of members: 6 (Allocation of seats to be determined in a later stage) + Chair out of quota

Luxembourg (date: week 38 in September¹).

¹ For a better preparation of the mission, it might be advisable to organise it after the hearing on the case study Luxembourg, hence in a later stage than September, possibly in the margin of a plenary week, either on Monday or on Thursday afternoon- Friday

Number of members: 5 (Allocation of seats to be determined in a later stage) + Chair out of quota.

Switzerland (date: week 44 in November).

Number of Members: 7 (Allocation of seats to be determined in a later stage).

The Coordinators also decided to organise a mission to Croatia in 2023 in order to discuss the recently introduced corporate tax reform.

4. Studies

The following studies are under preparation:

- Study on the “Removal of taxation-based obstacles and distortions in the Single Market in order to encourage cross border investment”;
- Study on the regulation intermediaries, including tax advisors, in the EU/Member States and best practices from inside and outside the EU;
- Study on the taxation of the informal economy.

Political groups were invited to provide the Secretariat with suggestions for possible additional studies.

D. Allocation of Rapporteurship of next INI reports

The Coordinators decided to allocate the INI reports as follows:

- “Lessons learnt from the Pandora Papers and other revelations” (S&D);
- “Further reform of corporate taxation rules” (EPP).

E. Mission to Washington, D.C.

On 3 March 2022, the Conference of Presidents authorised a FISC mission to Washington, D.C., from 23 to 25 May 2022 (week 21) with the participation of 7 Members in total.

The Coordinators endorsed the date and draft programme of the mission and were invited to provide further suggestions of meetings with key-stakeholders/players by Wednesday, 23 March 2022 at noon. The allocation of seats will be further discussed.

F. Annual Programming - Commission Work Programme (CWP)- FISC contribution to the Summary report 2022

In the context of the annual programming cycle, the Chair of the CCC invited the Committees to provide their contributions to the Summary report 2022 by 20 May 2022 at the latest.

Coordinators held a preliminary exchange of views and political advisors were invited to provide the Secretariat with proposals for priorities.

The final FISC contribution will be endorsed in the FISC coordinators meeting on 25 April 2022.

G. Possible meeting with the French Minister of Finances

The Coordinators took note of the proposed date of 20 April for the joint ECON/FISC exchange of views with Mr Le Maire. The secretariat is awaiting confirmation from the Minister's Office.
