ITEMS FOR DECISION

A. High Level Conference on Taxation

The Coordinators held an exchange of views on a draft programme.

In line with their decision taken on 25 April 2023, all coordinators (but EPP) confirmed their wish to organise a full day conference co-hosted with the European Commission, the Council and with the participation of national parliaments followed by half a day dedicated to technical workshops organised by the Commission only. The full day conference will take place in the European Parliament's premises. The event totalling 1,5 day will be organised on 25-26 October or 29- 30 November. Both days would be open to national parliamentarians, as well as the wider public audience.

The Coordinators agreed to organise 4 panels on the following themes: Tax Mix for the Future, Decision-making on taxation – combining the national, EU and international level, Corporate Income Taxation and Competitiveness Vs Fairness: what role can taxation play? This last panel should also address the issue of intergenerational fairness.

They also agreed to invite a Minister representing the Spanish and Belgian Council Presidencies as well as the OECD Secretary General.

The secretariat was invited to liaise with the Commission to prepare the conference and its programme.

Coordinators were invited to submit by 30 May suggestions for possible other speakers by written procedure. A concept note to share with invited speakers, will be circulated for comments by the FISC Secretariat.

B. Gender Mainstreaming Action Plan (*Annex I*)

Ms Kira Peter-Hansen presented the draft implementation report for the period from May 2022 to May 2023 prepared with Ms Monica Semedo, both FISC representatives in the Gender Mainstreaming Network.

The implementation report was adopted without comments (See annex I at this end of this summary).

C. Mission to Singapore - Week 30 (24 - 28 July)

The Coordinators endorsed a draft programme for the mission to Singapore. Coordinators decided to look into the possibility of inviting representatives of NGOs, either in person or virtually, before or during the mission.

D. Mission to Washington D.C. - Week 44 (30 October - 2 November)

The Coordinators were requested to submit their priorities of possible topics to be discussed and interlocutors to meet by 30 May. They also were invited to provide the Secretariat with the name of Members interested in taking part in this mission.

E. Request from the ECR Coordinator on the VAT treatment of vouchers

The Coordinators agreed to invite the negotiating team on the VAT in the Digital Age Package to send a letter to Commissioner for Economy, Paolo Gentiloni, in charge of Directorate-General Taxation and Customs Union, insisting on the delivery of the assessment report on the application of the VAT Directive as regards the VAT treatment of vouchers for goods or services.

F. Study on good tax practices and briefing on possible double taxation faced by Ukrainians

The Coordinators:

- invited the rapporteur on the INI report on "taxation in times of crisis" to request EPRS to prepare a briefing at short notice on potential double taxation faced by Ukrainians;
- agreed to request a study on good tax practices to be prepared by the Policy department.

G. Mission to the UK and its Crown Dependencies (19 to 22 June 2023)

The Coordinators took note of the draft programme for the mission to UK and its Crown Dependencies (Guernsey & Jersey).

H. Possible cooperation between committees of the Verkhovna Rada of Ukraine and FISC

The Coordinators took note of the joint letter sent by the Chairs of BUDG, CONT and FISC replying to the request from Mr Danylo Getmantsev, Head of Verkhovna Rada of Ukraine Committee on Finance, Taxation and Customs Policy to organise a joint meeting.

A bilateral meeting between the FISC Chair and the Head of Verkhovna Rada of Ukraine Committee on Finance, Taxation and Customs Policy took place on 24 May. Coordinators will be debriefed at the next meeting.

I. Change in the speaking order in FISC

Following a change in the composition of political groups, the ECR group now counts more Members than the ID group.

In line with the FISC working methods endorsed by Coordinators on 10 November 2020, the speaking order in FISC will be modified and reflect the plenary order, i.e. EPP, S&D, Renew, Greens/EFA, ECR, ID, The Left. This change will apply during hearings, exchanges of views as well as discussions on reports/opinions (for the shadow rapporteurs).

**FISC Action Plan on Gender Mainstreaming:
Background and assessment of progress after one
year of implementation
May 2023**

In line with the European Parliament's commitment to incorporate a gender perspective in all its activities, the coordinators of the FISC Subcommittee adopted a Gender Mainstreaming Action Plan on 25 May 2021. The plan foresees that its implementation is followed regularly by the Members responsible for gender mainstreaming and that the results will be presented in an annual report. The present implementation report covers the period between May 2022 and May 2023.

The implementation of the Action Plan over the past year has been acceptable. As regards the organisation of the Subcommittee's work, the selection of speakers when organising hearings and workshops was aimed at ensuring gender balance. Overall 36% of speakers were female over the period from May 2022 to May 2023, compared to 41% over the period from May 2021 to May 2022. The Subcommittee should invest further efforts to achieve gender balance in this area. For a detailed assessment see the attached Gender Balance Scoreboard.

Three missions (Dublin, Luxembourg and Bern) were organized in the period between May 2022 and May 2023. The overall share of female Members participating in these missions was 42% compared to 31% in the missions organized between May 2021 and May 2022. As regards the distribution of reports, 22% of rapporteurs and shadow rapporteurs were female in the past year, compared to 29% in the previous year. This share of female rapporteurs and shadow rapporteurs or participants in missions needs to be seen against the background that only 28,8% of FISC Members and Substitutes are female.

As of May 2023, the staff of the FISC Secretariat consists of one head of unit, four administrators (AD) and three assistants (AST). The proportion of women in the overall Secretariat staff amounts to 50%. Two AD posts had become vacant in the period May 2022 to May 2023 and were filled in December 2022 and January 2023. One AST post was filled in June 2022. The share of women in AD posts passed from 0% to 25% compared to the previous year and remained at 100% in AST posts. In total, the FISC Secretariat had two Schumann trainees, of which one was female.

In the area of policies, the gender perspective has played no significant role in any report, study, workshop, hearing or exchange of views. Due to a lack of resources in DG COMM, it was not possible to prepare a video compiling statements from several female FISC Members active in the tax area in the context of the Parliament's annual Gender Equality Week. Instead, Members were invited to publish individual video statements on Twitter, which were re-tweeted by the FISC Subcommittee's Twitter account.
