ITEMS FOR DECISION

A. High Level Conference on Taxation

On 8 June 2023, the CoP granted its authorisation to hold the conference on 25 October 2023. The Conference will be co-hosted with the European Commission.

The Commission will host workshops during half a day on 24 October 2023. The Coordinators had a general discussion on the list of suggested speakers and concept notes that were circulated ahead of the meeting.

They agreed on the list of suggested speakers and concept notes after a written consultation. They underlined that the overall composition of speakers as well as the distribution of keynote speeches should be balanced from a gender perspective. The EPP Coordinator called to ensure a political balance in the composition of the panels of the conference.

B. Mission to Singapore - Week 30 (24 - 28 July)

The Coordinators endorsed the draft programme for the mission to Singapore.

They were further invited to submit suggestions of relevant NGOs active in Singapore or in the region of Singapore, which could be met during or ahead of the mission.

C. Mission to Washington D.C. - Week 44 (30 October - 2 November)

The Coordinators endorsed the draft programme for the mission to Washington.

They further decided that a representative of the United Nations should be invited to discuss the work of the UN Committee on Taxation. Senator Bill Cassidy will be invited if one of the other Senators on the programme is not available.

D. Follow-up of the preliminary bilateral meeting between the Head of the Verkhovna Rada of Ukraine Committee on Finance, Taxation and Customs Policy and the FISC Chair

A majority of the Coordinators supports the creation of a standing team of MEPs responsible for the relations with Verkhovna Rada of Ukraine. The first online exchange of views between the Members of this group and the Rada Committee on Finance, Taxation and Customs Policy shall be organised to better understand the specific needs of the Rada Committee in the tax area and later define the way forward of cooperation.

Furthermore, taking into account the information from the European

Commission on the possible access to FISCALIS by the Rada, the Chair will inform his counterpart and, concerning the issue of double taxation, reiterate the request on their assessment as regards the number of Ukrainian citizens affected by this situation and their estimation of the revenue loss for the Ukrainian budget.

After the first meeting of the standing team for the relations with Rada and their counterparts, Coordinators will assess the need to establish a regular contact between the Group Political Advisors, FISC Secretariat and their counterparts in the Rada (using, as referred, the same model of the relations with Washington).

E. Follow-up to INI reports - Preparation of the exchange of views with Commissioner Gentiloni on 19 September 2023

The FISC Subcommittee has invited Commissioner Gentiloni to an exchange of views on tax matters, which will take place on 19 September 2023.

The Coordinators took note of:

- the monitoring table containing the Commission's follow-up to the EP resolutions adopted since the creation of FISC as well as ;
- the State of Play of Tax Proposals announced by the Commission since the beginning of the legislature

They decided not to send to the Commission written questions ahead this exchange of views.

F. Policy Coherence for Development (PCD) Network – Appointment of FISC Member

By a letter of 22 May 2023, the Chair of the DEVE committee has invited the FISC Subcommittee to appoint a Member to represent FISC in the PCD mainstreaming network.

As no Member who is both member of FISC and DEVE is available for this role, groups will be given another chance to indicate whether they are interested to participate in this network.
