The meeting opened at 15.12 on Monday 9 July 2012, with Malcolm Harbour (Chair) in the chair.

**2. Chair's announcements**

The Chair announced that opinion on *Re-use of public sector information* (Rapporteur: Rafał Trzaskowski) was taken out from the agenda as most linguistic versions of amendments were not available. The consideration of amendments will take place on 17 September.

The Chair informed Members that on 10 July there will be working lunch and later discussion during the IMCO Meeting with Mr. Neoklis Sylikiotis, Minister of Commerce, Industry and Tourism. The Chair indicated that the Cyprus government is very active and successful in the area of e-procurement.

The Chairman commented on the conclusions of the European Council which took place on 28-29 June 2012. The Council declared that the Members States will ensure a better implementation and reinforcement of Single Market Rules and the Commission will monitor performance, including annual report in the framework of the European Semester. At the moment ECON and EMPL are the lead committees on the European Semester issue. Mr. Harbour was asked by Mr. Schwab and Mrs. Gebhardt to push for a distinct role for IMCO regarding the European Semester.
