- a sustainable single market for businesses and consumers
- the future of free movement of services in the single market

Coordinators also agreed to hold a hearing on emerging digital technologies (AI, blockchain) related to the future proposal from the Commission on the machinery directive.

The exact titles of the INIs and the hearing will be fine-tuned by the Secretariat who will circulate the proposals to the Coordinators by a written procedure (given the deadline to submit the proposals to the CCC).
