I.4.1 Missions / delegations and hearings situation

Coordinators unanimously agreed to reschedule the mission to Paris (scheduled for week 15) and the mission to San Francisco (scheduled for week 22) in the second half of 2020 (if possible to travel), in replacement to the original proposals already agreed (Poland, China and Israel).

I.4.2 Addressing product safety in the Single Market (Walsmann INI)

Coordinators agreed that there will be no restrictions to the amendments tabled to the draft Report of the 2019/2190 INI relating, following the withdrawal of the 2013 Product safety and Market surveillance proposals by the Commission and the decision of 18 February 2020 by the Coordinators not to table a Motion for Resolution on these

proposals.

The timetable was updated as well to take into account the new schedule of the IMCO meetings.

I.4.3 Letter from the Commission on priorities and expected delays in CWP 2020

Coordinators took note of the information provided by letter of 6 April 2020 to the Chair of the CCC, Mr Antonio Tajani, of the revision of the 2020 Work Programme (CWP 2020), to take account of the need to re-focus on initiatives that will directly contribute to overcoming the crisis. As a consequence, a number of initiatives will be deferred to later in 2020 or 2021.
