An agreement is being sought in the framework of the pending conflict regarding the three Communications made by the Commission.

<p>Shaping Europe’s digital future COM(2020)0067</p> <p>A European strategy for data COM(2020)0066</p> <p>AI - a European approach to excellence and trust COM(2020)0065</p> <p>(AK, PS, TV, MS, MDB)</p>		<p>On 28 February, these 3 Communications were referred to ITRE.</p> <p>By letter of the Chair on 9 March, IMCO:</p> <ul style="list-style-type: none"> - contested the referrals on the Data Strategy and the AI White Paper; - requested that IMCO and ITRE be jointly responsible for the Communication on digital future. <p>On 26 March ITRE requested to produce only 2 INIs out of the 3 Communications: <i>“Ensuring European leadership in the digital age and an EU approach to Artificial Intelligence”</i> (merging the chapeau communication and the one on AI), and another on <i>“A European strategy for data”</i>.</p> <p>On 1 April, ITRE wrote a letter to the CCC Chair defending the referral of all three digital communications to ITRE and calling on him to dismiss IMCO's claims.</p> <p>On 8 April, the IMCO Chair responded briefly, pointing out several inaccuracies in ITRE’s arguments, and insisting on the challenge of the referrals.</p> <p>The CCC was expected to issue a recommendation to resolve this conflict after the deadline to find a bilateral agreement expired on 30 April, but that recommendation has not yet been issued.</p> <p>In view of the situation, the Secretariat requested information and further clarification of what is the state of play on these conflicts to the Legislative Coordination Unit (LEGI), and expressed concerns for the delay in the decision and the unprecedented approach taken so far, following which it appears that Committees would be entitled to work in parallel on similar issues.</p> <p>The IMCO Chair has exchanged emails with Mr Tajani, CCC Chair, insisting on those concerns. In this exchange, IMCO was informally advised that ITRE has the right to act upon these Communications, as any other committee, as long as the scope of the INI report requested remains</p>

		<p>within its competences as per Annex VI. IMCO has further clarified that the contestations also challenge ITRE's competence to draw up the relevant INIs.</p> <p>LEGI has also informally informed the Secretariat that ITRE has established a series of bilateral negotiations with JURI, ECON, LIBE, and TRAN Committees in search for an agreement on a division of competences on those files.</p> <p>Consequently, according to the above interpretation, as any committee has the right to act upon these Communications, Coordinators were consulted via a written procedure on 18 and 19 May. They decided to draw up INI reports reflecting IMCO's views on the matter, confirmed in their recent meeting of 25 May, when they confirmed this approach and decided to merge the report on shaping the digital future of Europe and the report on AI in one single report, and to draw up a separate report on the data strategy.</p> <p>During the CCC written procedure of 25/26 May, ITRE contested IMCO competence for all three reports. LIBE and ECON objected to the authorization of all three reports. JURI requested a clarification of the scope of the report on Shaping the digital future of Europe, and association under Rule 57 for all three reports. CULT requested to be associated under Rule 57 on the reports on Shaping the digital future of Europe and AI, and a clarification of the scope of the report on Creating a genuine single market for data. TRAN requested to be associated under Rule 57/58 on all three reports. INTA requested to be associated under Rule 57 on the report on Shaping the digital future of Europe, and opinions under Rule 56 for other two reports.</p> <p>Subsequently, LIBE, ECON, JURI, CULT, TRAN and INTA also sent letters to the CCC confirming their views and requests expressed during the CCC written procedure.</p> <p>The Secretariat is currently negotiating with the other committees in search for a possible agreement, to meet the CCC deadline of 19 June.</p>
