<b>CULTINI “Towards European Digital Public Sphere”</b>  (PS/BM)		On 29 October 2020, the CULT Committee requested authorisation to draw up a non-legislative own-initiative report on “Towards European Digital Public Sphere”. This concept is described as a digital ecosystem that would observe, in its technical design, values such as transparency and openness and that would create a digital space, thereby strengthening public debate and safeguarding and promoting media pluralism and cultural diversity that form part of Europe’s identity. The report intends to look into, among others, the organisation and financing of that sphere as well as the infrastructure-related aspects of the sphere’s expansion.

		<p>On 12 November 2020, IMCO requested clarification of the scope and the aim of the requested report, reserving a decision as to the scope of involvement that IMCO would request (potentially an association under Rule 57) on the CULT report, until that clarification is provided.</p> <p>Following exchanges on the requested report between the secretariats, CULT offered IMCO association under Rule 57 RoP with shared competences. Detailed modalities of the association are still under discussion.</p>
<b>IMCO INI “Tackling non-tariff barriers in the Single Market”</b>  (SvS/BM/CM)		IMCO decided to change the title of the INI into “Tackling non-tariff and non-tax barriers in the Single Market”. This change was agreed with the Rapporteur and endorsed by the Coordinators in a written procedure and will be reflected in the scope of the INI report.
<b>JURI INL “Digitalisation and Administrative Law”</b>  (TKV/SD)		On 18 December 2020, JURI requested authorisation to draw up a legislative own-initiative report on “Digitalisation and Administrative Law”. IMCO asked for an involvement under Rule 57 of the RoP for matters falling within its remit, in particular regarding the use of digital tools, artificial intelligence (AI) and data.
<b>IMCO hearing on “Regulation of online platforms and digital service providers in the digital single market: ensuring effective protection of European consumers in the digital economy”</b>  (AM/AK/PS/BM)		<p>During the CCC written procedure of 18/19 January, ECON asked for clarification that the planned hearing will not touch upon matters falling with the competences of the ECON committee. ECON reserved its position on the request for authorisation of the hearing until the above-mentioned clarification has been received.</p> <p>Despite IMCO’s reassurance letter of 5 February, ECON decided to maintain its reservations on the hearing proposed by IMCO. IMCO Hearing will therefore not take place on 22 February as initially envisaged.</p>
<b>Regulation on a ‘Single Market For Digital Services (Digital Services Act) and amending Directive’</b>	COM(2020)0825 2020/0361(COD)	Coordinators stressed that IMCO should lead on both files as they are undoubtedly internal market instruments. They agreed to support the Chairwoman in defending IMCO’s interests towards other committees and in the CCC. They also stressed that conflicts with other committees

Furthermore, ITRE requested shared competence under Rule 57 on provisions regarding the technical harmonisation requirements, the presumption of conformity, the obligations of manufacturers, the carbon footprint, the repurposing, and the battery passport.</p> <p>A reply letter rejecting those requests was sent to CCC by IMCO on 8 February. IMCO suggested associating ENVI on Chapter VII of the proposal, regarding the “End-of-life management of the batteries”. ITRE, on the other hand, was invited to provide its contribution under Rule 56+ on the provision regarding the raw materials, and under rule 56 for the other parts.</p>

<b>Directive on measures for a high common level of cybersecurity across the Union, repealing Directive (EU) 2016/1148</b>  (AM/AK)	COM(2020)0823 2020/0359(COD)	IMCO requested association with ITRE under Rule 57 (shared and exclusive).
<b>Directive on the resilience of critical entities</b>  (MaC/AK)	COM(2020)0829 2020/0365(COD)	On 2 February 2021, a letter was sent to the Chair of the CCC to request Rule 57, with exclusive competence for topics, falling under IMCO's responsibilities and shared competence for other aspects of the proposal. Following an offer by the Chair of LIBE for involvement of IMCO under Rule 57 with <u>shared</u> competences for the provisions for which IMCO had previously requested an exclusive competence, Coordinators agreed to such involvement.
<b>Regulation on a Data Governance Act</b>  (TKV, AM)	COM(2020)0767 2020/0340(COD)	On 25 November 2020, the Commission put forward a proposal for a Regulation on European data governance (Data Governance Act). The proposal was announced in Plenary on 14 December and referred to ITRE.  On 28 January, Coordinators of IMCO decided to request to be associated under Rule 57 with exclusive and shared competences, and on 5 February, a letter from the Chair of IMCO was sent to the CCC.  On 8 February, the Chair of IMCO was informed by the Chair of CCC that the letter from IMCO was submitted outside the period foreseen in Rule 211(1) of the Rules of Procedure and would therefore not be considered by the CCC. The Chair of CCC suggested to negotiate modalities of cooperation directly with ITRE. Therefore, a letter from the Chair of IMCO was sent to the Chair of ITRE asking to be associated with exclusive and shared competences.
