I.2.1 Main items of the Conference of Committee Chairs

The Chair informed of the discussions on UK-EU TCA, and on committees' staffing situation with the Rapporteur on the budget 2022. As at the next meeting, CCC will discuss remote working best practices in parliamentary committees, the Chair invited the Coordinators to inform her of their suggestions for improvements.
