Il-President fakkret lill-Membri tal-PE li l-Koordinaturi kienu qablu dwar qafas adattat għall-iskambju ta' fehmiet dwar ir-Rapporti/l-Opinjoni li jirrestringi l-kelma lil Membru tal-PE wieħed għal kull Grupp Politiku (normalment ix-shadow jew is-sostitut tiegħu/tagħha) għal tul ta' ħin limitat. Dan jirrifletti l-limitazzjoni imposta għal-laqgħat kollha tal-kumitati, u l-ħtieġa li tingħata prijorità lill-punti tal-aġenda relatati ma' kwistjonijiet tal-COVID-19.

The Chair informed of the CCC meeting with Commission EVPs and VPs on 5 October in view of the preparation of the Commission Work Programme 2022.

The Chair informed of the exchange of views with President Sassoli on the recommendations of the Focus Groups on post-Covid-19 Parliament.

		<p>The Chair wrote to the CCC Chair to respond to all claims, asking to maintain IMCO’s lead and offering cooperation under Rule 56 and 57.</p> <p>A virtual meeting took place between the CCC Chair and other relevant Committee Chairs on 29 September, however no solution was found to the conflict.</p> <p>The CCC recommendation was issued on 8 October with the following:</p> <ul style="list-style-type: none"> • Rule 58 (joint committee procedure) for JURI; • Rule 57 (exclusive and shared competences) for ITRE; • Rule 57 (shared competences) for LIBE; • Rule 57 (shared competences) for CULT.
<p>Proposal for a Regulation of the European Parliament and of the Council on machinery products</p> <p>(BM/SvS/MaC)</p>	2021/0105(COD)	<p>On 6 July, EMPL sent a letter to the CCC, requesting association under Rule 57 RoP with shared competences on a number of Articles and exclusive competence on one Recital. On 12 July, IMCO Chair responded, stating that the EMPL request doesn’t seem justified as Occupational Health and Safety provisions are not part of the proposal.</p> <p>On 14 September, EMPL sent another letter reaffirming its request, to which IMCO responded along the same lines as in the first letter and invited EMPL to submit an opinion under Rule 56.</p> <p>Contacts between the Chairs in order to try to find a workable but legally sound solution haven’t been successful either.</p> <p>On 4 October, EMPL sent another letter, admitting that no agreement is possible with regard to their request and asking CCC for a recommendation on the matter.</p>
<p>Foreign subsidies distorting the internal market</p> <p>(MCz/PhS)</p>	2021/0114(COD)	<p>IMCO Coordinators decided to request Rule 58 or 57 exclusive. First and second meeting between IMCO and INTA Chairs was not conclusive. Thus IMCO Chair sent a letter to the CCC requesting Rule 58.</p> <p>By letter to the CCC, ECON requested to be assigned the lead instead of INTA.</p> <p>On 5 July INTA, refused by letter to CCC both the claims of IMCO and ECON.</p>

		<p>On 31 August, ECON requested again lead for the file or alternatively an ECON-INTA split of the report.</p> <p>On 3 September, IMCO by letter to CCC requested Rule 58 again and rebuffed the claims of INTA and ECON.</p> <p>The CCC decided to prolong the initial deadline of 20 September to resolve the conflict.</p>

By a second letter to the CCC, IMCO repeated its initial request.</p> <p>On 4 October 2021, ITRE, JURI and LIBE sent to the CCC a common agreement on the collaboration modalities for the proposal, where some of the provisions requested by IMCO were offered to JURI. IMCO is offered exclusivity again only on the two provisions relating to accessibility.</p>
<p>Consumer Credits</p> <p>(SD/CM)</p>	2021/0171(COD)	<p>The file was announced in Plenary on 8 July and was referred to IMCO as lead committee and to ECON for an opinion.</p> <p>On 27 July, by letter to the CCC, ECON challenged IMCO's competence and requested the reattribution of the lead responsibility.</p> <p>IMCO replied by a letter, asking to maintain the lead and offering cooperation under Rule 56 RoP.</p> <p>In reaction to this, ECON did not approach IMCO for any cooperation agreement but sent a second letter, providing further observations to substantiate its request to challenge IMCO's competence and request the reattribution of the lead responsibility.</p> <p>IMCO will reply by a letter, insisting on its initial position and – given ECON's lack of cooperation spirit - requesting that a recommendation be made by the CCC.</p>

<p>Regulation on a Data Governance Act</p> <p>(TKV, AM)</p>	<p>2020/0340(COD)</p>	<p>On 25 November 2020, the Commission presented the proposal for a Regulation on European data governance (Data Governance Act), which was referred to ITRE.</p> <p>IMCO requested association under Rule 57 with exclusive and shared competences, which was rejected. Consequently, IMCO requested, through bilateral negotiations with ITRE, association under Rule 56+, which was also rejected by ITRE. Instead, ITRE invited IMCO to submit a simple Opinion (Rule 56) with elements of enhanced cooperation, meaning that the IMCO Rapporteur would be invited to shadows' meetings and other relevant meetings until the adoption of the ITRE report. No further involvement of IMCO during negotiations etc. was envisaged by ITRE.</p> <p>However, the ITRE Rapporteur appreciated IMCO's input into the report and the cooperation when establishing the compromise amendments. Therefore, the ITRE Rapporteur has decided to continue inviting the IMCO Rapporteur to relevant meetings (shadows meetings/trilogues).</p>

I.5. Miscellaneous

I.5.1 Preparation of votes on DMA and DSA

Decision: Coordinators endorsed the proposed arrangements for the vote on DMA and DSA but stressed the need of early coordination with the Rapporteurs on any need to put amendments which are not replaced by compromises to vote individually, where consistency allows, without an explicit limit to the number of such votes.

I.5.2 Oral Question on barriers to the free movement of goods (GDS)

Decision: Coordinators approved the Oral Question on the free movement of goods so that it can be submitted to vote in committee.

I.5.2 Hearing on whistle-blowers testimonies on the negative impact of big tech companies' products on users (AK)

Decision: Coordinators decided to organise the proposed hearing on Facebook whistle-blower's testimonies on 8 November 2021, and to postpone the hearing on sustainable

public procurement to 1 December 2021.

I.5.3 Hearing on targeted advertising on online platforms (AK)

Decision: Coordinators asked the secretariat to explore possible ways of organising a hearing-type event on targeted advertising on online platforms before the vote on DSA in committee.
