2. Puheenjohtajan ilmoitukset

A. Tulkkaus

Tulkkaus on saatavilla 16 kielellä ensimmäisen kokousjakson aikana (tanska vain passiivisesti) ja 22 kielellä julkisessa kuulemisessa. Puhujia pyydettiin käyttämään äidinkieltään, mikäli se oli yksi tulkattavista kielistä.

B. Ajankäyttö

Puheenjohtaja muistutti jäseniä siitä, että koordinaattorit ovat sopineet mukautuksesta mietintöjä ja lausuntoja koskeviin keskusteluihin: kustakin poliittisesta ryhmästä keskusteluun voi osallistua yksi jäsen (yleensä varjoesittelijä tai tämän sijainen), ja puheenvuoroa varten käytettävissä oleva aika on rajallinen. Näin toimitaan, koska kaikkien valiokuntakokousten kesto on rajoitettu ja koska covid-19-pandemiaan liittyvät aiheet on asetettava etusijalle.

C. Suoratoisto verkossa ja eMeeting-sovellus

Puheenjohtaja muistutti jäseniä siitä, että kokous lähetetään suoratoistona verkossa ja että kokousasiakirjat ovat saatavilla tabletilla tai kannettavalla tietokoneella eMeeting-sovelluksen kautta, sillä IMCO-valiokunta työskentelee paperittomasti.

By a second letter to the CCC, IMCO repeated its initial request.</p> <p>On 4 October 2021, ITRE, JURI and LIBE sent to the CCC a common agreement on the collaboration modalities for the proposal, where some of the provisions requested by IMCO were offered to JURI. IMCO is offered exclusivity again only on the two provisions relating to accessibility.</p> <p>Further to a new letter sent by IMCO and reopening of the negotiations, an agreement was found between Committees on 27 October, granting IMCO exclusive competence on accessibility and mutual recognition, and shared competences notably on digital wallets.</p>
