Sanāksmes pirmajā daļā mutiskais tulkojums bija pieejams 16 valodās (dāņu valodā — tikai pasīvi), bet atklātās uzklausīšanas laikā — 22 valodās. Runātāji tika aicināti uzstāties dzimtajā valodā, ja tā ir viena no valodām, kurās ir pieejams mutiskais tulkojums.

#### B. Laika pārvaldība

Sanāksmes vadītāja atgādināja EP deputātiem, ka koordinatori ir vienojušies par pielāgotu sistēmu viedokļu apmaiņai par ziņojumiem/atzinumiem, saskaņā ar kuru vārdu var dot tikai vienam deputātam no katras politiskās grupas (parasti ēnu referentam vai viņa aizstājējam) uz ierobežotu laiku. Tas atspoguļo ierobežojumu, kurš attiecas uz visām komiteju sanāksmēm, un nepieciešamību piešķirt prioritāti darba kārtības jautājumiem, kas saistīti ar Covid-19.

Sanāksmes vadītāja atgādināja deputātiem, ka sanāksme tiek straumēta tiešsaistē un sanāksmes dokumenti ir pieejami planšetdatoros vai klēpjatoros lietotnē eMeeting, jo IMCO komiteja vispār neizmanto papīra dokumentus.

<b>Proposal for a Regulation of the European Parliament and of the Council on machinery products</b>  (BM/SvS/MaC)	2021/0105(COD)	<p>On 6 July, EMPL sent a letter to the CCC, requesting association under Rule 57 RoP with shared competences on a number of Articles and exclusive competence on one Recital. On 12 July, IMCO Chair responded, stating that the EMPL request doesn't seem justified as Occupational Health and Safety provisions are not part of the proposal.</p> <p>On 14 September, EMPL sent another letter reaffirming its request, to which IMCO responded along the same lines as in the first letter and invited EMPL to submit an opinion under Rule 56. Contacts between the Chairs in order to try to find a workable but legally sound solution haven't been successful either.</p> <p>On 4 October, EMPL sent another letter, admitting that no agreement is possible with regard to their request and asking CCC for a recommendation on the matter.</p> <p>A CCC recommendation is in preparation.</p>
<b>Foreign subsidies distorting the internal market</b>  (MCz/PhS)	2021/0114(COD)	<p>IMCO Coordinators decided to request Rule 58 or 57 exclusive. IMCO Chair sent a letter to the CCC requesting Rule 58.</p> <p>By letter to the CCC, ECON requested to be assigned the lead instead of INTA.</p> <p>On 5 July INTA, refused by letter to CCC both the claims of IMCO and ECON.</p> <p>On 31 August, ECON requested again lead for the file or alternatively an ECON-INTA split of the report.</p> <p>On 3 September, IMCO by letter to CCC requested Rule 58 again and rebuffed the claims of INTA and ECON.</p> <p>The CCC decided to prolong the initial deadline of 20 September to resolve the conflict. ITRE replied, offering to IMCO only two provisions on accessibility. By a second letter to the CCC, IMCO repeated its initial request.</p> <p>On 4 October 2021, ITRE, JURI and LIBE sent to the CCC a common agreement on the collaboration modalities for the proposal, where some of the provisions requested by IMCO were offered to JURI. IMCO is offered exclusivity again only on the two provisions relating to accessibility.</p> <p>Further to a new letter sent by IMCO and reopening of the negotiations, an agreement was found between Committees on 27 October, granting IMCO exclusive competence on accessibility and mutual recognition, and shared competences notably on digital wallets.</p>
<b>Consumer Credits</b>  (SD/CM)	2021/0171(COD)	<p>The file was announced in Plenary on 8 July and was referred to IMCO as lead committee and to ECON for an opinion.</p> <p>On 27 July, by letter to the CCC, ECON challenged IMCO's competence and requested the reattribution of the lead responsibility.</p> <p>IMCO replied by a letter, asking to maintain the lead and offering cooperation under Rule 56 RoP.</p> <p>In reaction to this, ECON did not approach IMCO for any cooperation agreement but sent a second letter, providing further observations to substantiate its request to challenge IMCO's competence and request the reattribution of the lead responsibility.</p> <p>IMCO replied by a letter on 7 October detailing its initial position and – given ECON's lack of cooperation spirit - requesting that a recommendation be made by the CCC upholding</p>

		the lead of IMCO. The recommendation is expected for November.
<b>IMCO Hearing - Impact of restrictions imposed during the COVID-19 crisis on the free movement of professionals and way forward</b>  (MaC/AK)		<p>IMCO Coordinators approved by written procedure to organise the hearing in the first half of 2022 to be endorsed by the CoP. The hearing should take place on 24/25 January 2022.</p> <p>EMPL insists to be involved in this hearing, which means having the possibility to select 1 speaker and participation of the EMPL Chair + 1 Member. The secretariat has made clear that this request is not acceptable for IMCO, as the hearing would focus on the restrictions to professional services, which relate to IMCO competences.</p> <p>The IMCO Chair will get in touch with the Chair of EMPL to discuss this further.</p>
