B. Ajankäyttö

Puheenjohtaja muistutti jäseniä siitä, että koordinaattorit ovat sopineet mukautuksesta mietintöjä ja lausuntoja koskeviin keskusteluihin: kustakin poliittisesta ryhmästä keskusteluun voi osallistua yksi jäsen (yleensä varjoesittelijä tai tämän sijainen), ja puheenvuoroa varten käytettävissä oleva aika on rajallinen. Näin toimitaan, koska kaikkien valiokuntakokousten kesto on rajoitettu ja koska covid-19-pandemiaan liittyvät aiheet on asetettava etusijalle.

I.5.2 IMCO travel activities in the 1st half of 2022

Decision: Coordinators took note of the situation regarding authorisation of IMCO missions/delegation within the EU for the first half of 2022. Coordinators indicated their wish to maintain the IMCO mission to Ireland and Northern Ireland and willingness to consider possible convergence of IMCO and AFCO missions to that Member State. The Chair will take up this mission with INTA and AFET Chairs and revert back to the Coordinators.
