Mødet den 9. december 2021 kl. 9.30-12.30 og 13.45-15.45

BRUXELLES

Mødet blev åbnet tirsdag den 9. december 2021 kl 9.32 under forsæde af Anna Cavazzini (formand).

1. Valg af tredje næstformand

Formanden

1. meddelte navnene på de stedfortrædere, der deltog i afstemningen (som blev indgivet af de politiske grupper), og understregede, at de politiske grupper i tilfælde af ændringer skulle underrette formanden, inden afstemningen erklæredes for åben¹,
2. mindede om, at medlemmer og stedfortrædere, der deltog i afstemningen uden fysisk at være til stede, kunne vælge at bruge knappen "ræk hånden op", hvis de gerne ville have ordet.

¹ Artikel 209, stk. 6-7: "De politiske grupper og løsgængerne kan for hvert udvalg udpege et antal stedfortrædere [...]. Disse stedfortrædere har ret til at deltage i og tale på udvalgets møder samt, såfremt det ordinære medlem ikke er til stede, til at deltage i afstemninger. Det ordinære medlem kan vælge et andet medlem af samme politiske gruppe eller, hvis medlemmet er løsgænger, en anden løsgænger til at repræsentere sig ved møderne og stemme på sine vegne. Udvalgets formand underrettes senest ved påbegyndelsen af afstemningen."

3. kontrollerede, om et beslutningsdygtigt antal medlemmer var til stede (1/4 af medlemmerne) [IMCO: 12 medlemmer]²;
4. anmodede om kandidaturer til posten som fjerde næstformand.
5. sørgede for, at:
 - (a) en kandidat indstilles enten af en politisk gruppe eller af mindst 5 % af udvalgets medlemmer [IMCO: 3 medlemmer]³;
 - (b) en kandidat giver sit samtykke til at blive indstillet⁴;
 - (c) en kandidat er ordinært medlem af udvalget⁵;
 - (d) en kandidat på behørig vis har udfyldt erklæringen om økonomiske interesser⁶ og erklæringen vedrørende kodeksen for passende adfærd⁷.
