## 1. Priekšsēdētājas trešā vietnieka vai trešās vietnieces ievēlēšana

Priekšsēdētāja:

1. paziņoja to **aizstājēju** vārdus, kuri piedalījās balsošanā (ko iesniegušas politiskās grupas), un uzsvēra, ka jebkādu izmaiņu gadījumā politiskajām **grupām priekšsēdētāja par to jāinformē, pirms balsošana tiek paziņota par sāktu**<sup>1</sup>;
2. atgādināja, ka **komitejas locekļi un aizstājēji, kas balsošanā piedalās attālināti** un vēlas izteikties, var izmantot pogu “pacelt roku”;
3. pārbaudīja, vai **ir sasniegts kvorums** (1/4 komitejas locekļu [IMCO:

  - c) kandidāts ir **pilntiesīgs** komitejas loceklis<sup>5</sup>;
  - d) kandidāts ir **pienācīgi aizpildījis finansiālo interešu deklarāciju**<sup>6</sup> un **deklarāciju attiecībā uz Pienācīgas uzvedības kodeksu**<sup>7</sup>.

**Lēmums:** Krzysztof HETMAN (PPE) tika ievēlēts ar aklamāciju par IMCO komitejas priekšsēdētājas trešo vietnieku.

Tas atspoguļo ierobežojumu, kurš attiecas uz visām komiteju sanāksmēm, un nepieciešamību piešķirt prioritāti darba kārtības jautājumiem, kas saistīti ar Covid-19.

#### C. Straumēšana tiešsaistē un lietotne eMeeting

Sanāksmes vadītāja atgādināja deputātiem, ka sanāksme tiek straumēta tiešsaistē un sanāksmes dokumenti ir pieejami planšet datoros vai klēpj datoros lietotnē eMeeting, jo IMCO komiteja vispār neizmanto papīra dokumentus.
