Sammanträdet öppnades torsdagen den 9 december 2021 kl. 9.32 med utskottets ordförande, Anna Cavazzini, som ordförande.

1. Val av tredje vice ordförande

Ordföranden

1. meddelade namnen på de **suppleanter** som deltog i omröstningen (enligt information ingiven av de politiska grupperna) och underströk att om någon förändring hade skett måste de politiska **grupperna informera ordföranden innan omröstningen förklarades påbörjad**¹,
2. påminde om att **ledamöter och suppleanter som deltog i omröstningen på**

3. kontrollerade att beslutsförhet förelåg (en fjärdedel av ledamöterna [IMCO: 12 ledamöter])²,
4. bad om förslag på kandidater till valet av tredje vice ordförande.
5. säkerställde att
 - a) en kandidat hade nominerats antingen **av en politisk grupp** eller **av minst en tjugondel av utskottets ledamöter** [IMCO: 3 ledamöter]³,
 - b) kandidaten hade gett sitt **godkännande** till att nomineras⁴,
 - c) kandidaten var **ordinarie** utskottsledamot⁵,
 - d) kandidaten i **vederbörlig ordning** hade **fyllt i förklaringen om ekonomiska intressen**⁶ och den **förfarande som avser koden för lämpligt uppträdande**⁷.

Beslut: Krzysztof HETMAN (PPE) valdes med acklamation till IMCO-utskottets tredje vice ordförande

² Artikel 218.2: ”I ett utskott föreligger beslutsförhet när minst en fjärdedel av ledamöterna är närvarande. Om ledamöter eller en eller flera politiska grupper som uppnår minst det höga tröskelvärdet i utskottet, innan omröstningen inleds, så kräver, ska emellertid omröstningen anses giltig endast om en majoritet av utskottets ledamöter har deltagit i den.”

Artikel 179.1 c tillämpas på utskotten genom artikel 219 i tillämpliga delar: ”Högt tröskelvärde: en femtedel av parlamentets ledamöter, som utgörs av en eller flera politiska grupper eller enskilda ledamöter, eller en kombination av bådadera.”

Artikel 179.4: ”Stöd av en politisk grupp ska räknas på följande sätt när det gäller tillämpningen av det medelhöga och det höga tröskelvärdet: I de fall då en artikel som fastställer ett sådant tröskelvärde åberopas under ett sammanträde eller möte: alla ledamöter som tillhör den stödjande gruppen och är fysiskt närvarande.”

Ordföranden påminde ledamöterna om att samordnarna hade enats om en anpassad ram för diskussioner om betänkanden/yttranden, vilket innebar att endast en ledamot per politisk grupp (vanligtvis skuggföredraganden eller dennes ersättare) fick yttra sig, och att inläggene var tidsbegränsade. Detta återspeglade den begränsning som hade införts för alla utskottssammanträden och behovet av att prioritera de punkter som avser covid-19-frågor.
