Coordinators took note that the IMCO mission to Paris scheduled to take place from 19 to 21 September was cancelled.

### **1.1.4 I.4.3. IMCO delegation to South Korea (31 October - 4 November 2022)**

Coordinators unanimously appointed Andreas Schwab as head of the delegation to South Korea.

Coordinators also agreed on a general rule for the replacement of the Chair in case she is not part of a delegation.

In this case, following the protocol order, the delegation shall be headed either by a Vice-Chair or, if no Vice-Chair is part of the delegation, by a Coordinator.

## ***1.5. Hearings***

### **1.1.5 I.5.1. Proposals for IMCO public hearings in the first half of 2023**

Coordinators considered the list of suggestions and decided to request authorisation for the following hearings:

- Standardisation
- Modernising the regulation of online platforms intermediating short-term accommodation rental services
- The state of consumer rights in the EU in times of crisis: how are they enforced and is effective redress available (this hearing shall also cover passenger rights and the impact of inflation)
- Child safety online.

#### 1.1.6 I.5.2. “30<sup>th</sup> anniversary of the Single Market”

##### 1.1.7 I.5.2.1. Public hearing “30<sup>th</sup> anniversary of the Single Market” **(27 October 2022)**

Coordinators decided on alternative keynote speakers to be invited in replacement of J.C. Juncker.

Coordinators also mandated the Secretariat to liaise with DG COMM with regard to possible communication products (e.g. the production of an infographic).

##### **I.5.2.2 Additional initiatives and activities:**

Coordinators discussed different initiatives to be launched to commemorate the 30th anniversary of the Single Market, by the European Parliament and the Commission (DG Grow) in particular.

They mandated the Chair to send a letter on behalf of IMCO to the EP President to suggest various activities during the January I EP Plenary part-session.

Coordinators also mandated the Secretariat to liaise with DG COMM with regard to possible communication products (e.g. the production of a short communication video to be shown in plenary).

##### 1.1.8 I.5.3. Public hearing “Right to repair: Strengthening consumer rights and empowering consumers to use products longer” **(originally planned 26 October 2022)**

Coordinators endorsed the change of date for this hearing that will now be held on 8th December.

##### 1.1.9 I.5.4. Public hearing “Construction Products Regulation” **(10 October 2022)**

Coordinators endorsed the suggested programme of the hearing.

##### 1.1.10 I.5.5. Exchange of views on “Impact of the Inflation on Consumers”

Coordinators agreed to organise, during the 26/27 October IMCO meeting, an exchange of views with Commission and stakeholders on the “Impact of the Inflation on Consumers”.

***1.6. Proposals for IMCO studies for the second half of the parliamentary term***

Discussion and decision postponed to the next meeting.

***1.7. Proposals for IMCO INIs for the second half of the parliamentary term***

The timely launch of one INI to fill the available slot will be decided by written procedure.

Discussion and decision of the INIs for the second half of the term postponed to the next meeting.

***1.8. Establishment of IMCO Working Groups on the Implementation of DMA and DSA***

Coordinators decided on the establishment of IMCO working groups on the implementation of DMA and DSA.

Both working groups will be composed of:

Chair: IMCO rapporteur;

Members: IMCO shadows + rapporteurs of the associated committees.

Each WG will to agree its *modus operandi* and report back on a regular basis to the IMCO Committee in public debates.

At the end of the mandate DMA and DSA WGs will need to be reviewed.



## ***1.9. Follow-up to Future of Committee working regime***

### **1.1.11 1.9.1. Committee meetings**

During the **Coordinators meeting on 12 July 2022**, the Chair already decided, on a case-by-case basis, and with the approval of Coordinators representing the majority of Committee Members that the following meetings will take place under the hybrid working regime: Thu 8 September, Mon 10 October, Wed 26/Thu 27 October, Mon 28/Tue 29 November, Thu 8 December.

It was also decided in July to hold all Coordinators meetings and votes in physical presence only.

### **1.9.2 Joint IMCO-LIBE Committee meeting 26 October 2022**

The Chair decided, with the approval of Coordinators representing the majority of Committee Members, to hold the joint IMCO-LIBE Committee meeting on 26 October 2022 in hybrid format (for IMCO Members).

### **1.9.3 Interinstitutional technical preparatory meetings for trilogues**

The political groups and the Czech Presidency agreed to hold the upcoming interinstitutional technical preparatory meetings on the Machinery Product Regulation, Standardisation Regulation, General Product Safety Regulation and Consumer Credit Directive in hybrid mode. This agreement was dictated by the political will to reach a speedy agreement on these four important files.

With the unanimous approval of all Coordinators, the Chair endorsed this agreement.
