## COORDINATORS DECISIONS OF 14 JUNE 2022

- Following the constituent meeting of the Special Committee ING2, the Coordinators agreed on the work programme, which includes in particular:

- Committee hearings with experts on:

- Russian disinformation and propaganda regarding Ukraine in the light of its war of aggression (a first hearings with SEDE/ING2 was held on 17 May; a second hearings will be hold in cooperation with standing committees and delegations concerned in September 2022 (date and time tbc);

- Russian interference: the distinct cases of Hungary and Spain (Catalonia) - in cooperation with standing committees and delegations concerned in October 2022 (date and time tbc);

- Interference and disinformation in EU Applicant and Western Balkans Countries - in cooperation with standing committees and delegations concerned in October 2022 (date and time tbc);

- China's interference and disinformation activities in Africa - in cooperation with standing committees and delegations concerned in November 2022 (date and time tbc);

- Climate change disinformation: International disinformation impact on the EU's climate goals - in cooperation with standing committees and delegations concerned in December 2022 (date and time tbc).

- Top priority areas of the INGE-Report to be followed up, in the form of exchanges of views with Members of the European Commission in cooperation with standing committees and delegations concerned:

- EU action to counter cyber-attack capabilities, in particular from Russia, and EU cyber security protection of critical infrastructure incl. evaluation of application of legislation in force (e.g. NIS2 Directive, EU FDI regulation);

- Operational structure and division of labour of EU anti-interference bodies;

- Media and digital literacy and education (including elaboration of curricula and life-long-learning contents on handling of mass media and social media, universities networking), and European Media Freedom Act and support for quality journalism;
  - Sanctions regime against malicious foreign interference and disinformation and hybrid threats including in the online sphere (in full respect of the freedom of expression);
  - Transparency, accountability, and responsibility of social media platforms (voluntary self-regulation e.g. EU Code of Practice 2022 revision vs. binding EU legislation, platform cooperation with law-enforcement bodies);
  - Closing loopholes on malicious covert funding of political activities by third-country donors and elite capture (electoral laws in Member States, transparency rules for stakeholders/lobbyism);
  - Data market and mining and open-source based network operating systems;
  - Protecting EU and Member States institutions including in the digital domain (resilience measures against cyber- and disinformation attacks including from PR consultancies/agencies performing disinformation services);
  - Interference and disinformation by religious organisations in the Western Balkans (Orthodox Church and others);
  - Bolstering the role of civil society to combat foreign interference and disinformation;
  - Foreign interference and influence in electoral processes: protecting electoral integrity and fostering societal democratic resilience.
- Connecting with policy makers in Europe and around the world by organising several inter-parliamentary committee meetings on the legislative resilience/electoral laws or information manipulation campaigns, with a special focus on countries that will have legislative and/or presidential elections before 2024.
  - ING2 Coordinators agreed as well on the missions in 2022, namely
    - Ukraine (as soon as operationally feasible in 2022 or if necessary in 2023);



- NATO StratCom to Riga, Latvia, which took place from 24/05 - 25/05/2022. Bilateral meetings with NATO StratCom and participation in Riga StratCom Dialogue 2022.
- European Centre of Excellence for Countering Hybrid Threats, Finland (Dates to be confirmed by the European Centre);
- Australia (possibly green week 38, September 2022)
- United Nations Electoral Assistance Division (UNEAD; NYC) (possibly green week 44, October/November 2022)

Finally, Coordinators discussed as well missions of the Special Committee in 2023 (South Africa, and Bosnia-Herzegovina and Serbia). Before each mission, the Coordinators will be asked to confirm the destination and to decide about the draft programme and the composition of the mission.
