**2.1. Indicative Calendar of Committee meetings for the year 2022**

**Decision:** *To approve the indicative calendar of committee meetings for 2022, bearing in mind that it is subject to modifications.*

**4.1. Competition policy - annual report 2021**

**Decision:** *Not to draft an opinion.*

**7.1. INTA delegation to the United Kingdom**

**Decision:** *To further postpone a decision on the new dates for the delegation to UK, but to request it as extraordinary delegation as soon as possible depending on the developing political situation.*

**7.2. INTA delegations for the 1st half of 2022**

**Decision:** *(1) To request an authorisation for the following delegations during the first semester of 2022: (i) Mexico (Mexico City), week 8 (21-25 February); (ii) India (New Delhi and Mumbai), week 15 (11-15 April); and (iii) Chile (Santiago and Valparaiso), week 21 (23-27 May); and (2) To preliminarily foresee a delegation to Mercosur during the second semester of 2022.*

**8.1. Hearings for the 1st half of 2022**

**Decision:** *(1) To request an authorisation for the following hearings during the first semester of 2022: (i) "EU-Africa Trade and Investment Relations" (during 24-25 January committee meeting); (ii) "Anti-coercion instrument in the EU Trade Defence toolbox" (during 28 February committee meeting); and (iii) "Trade-related aspects of the Northern Ireland Protocol" (during 21-22 March committee meeting); (2) To actively reach out to JURI and other committees to be included in possible hearings on due diligence; and (3) To preliminarily foresee a hearing on Indo-Pacific strategy during the second semester of 2022.*

**8.2. Postponement of Joint INTA-SEDE Hearing on 'Assessing the risks and policy responses to foreign direct investment, including Chinese investments in the security and defence sectors'**

**Decision:** *To decide to postpone the joint hearing until early 2022.*

**8.3. Approval of programme of the public hearing on 'international investment policy and investment protection reform'**

**Decision:** *To approve the programme for the hearing on "International investment policy and investment protection reform" scheduled for 26 October 2021.*

**10.1. Possible inclusion of Afghanistan in one of the existing INTA Monitoring Groups**

**Decision:** *To discuss Afghanistan when need be in the Monitoring Group on the Generalised Scheme of Preferences (GSP), chaired by standing rapporteur Emmanouil Fragkos (ECR).*

**11.1. Motion for a European Parliament resolution on timber exports to China (B9-0420/2021)**

**Decision:** *To take note of the proposed motion for resolution, and decide not to follow it up with specific action and, in line with Rule 143(6), to inform the author of the decision of the committee.*

**11.2. Motion for a European Parliament resolution on EU cooperation with Pakistan in the context of new Taliban regime in Afghanistan (B9-0472/2021)**

**Decision:** *To take note of the proposed motion for resolution, and decide not to follow it up with specific action and, in line with Rule 143(6), to inform the author of the decision of the committee.*

**16. Requests from political groups**

**Decision:** *(1) To include at one of the upcoming INTA meetings a presentation of and exchange of views on the Joint Communication “The EU strategy for cooperation in the Indo-Pacific”; (2) All Coordinators to recall the INTA Members of their respective Groups the importance of confidence and confidentiality of ‘in camera’ discussions and Chair to send a communication to all INTA Members, assistants and staff recalling the same; (3) To schedule a technical meeting with the Commission about the suspension of the anti-dumping duties on Chinese aluminium and more in general on the impact of global supply shortages on trade defence; (4) To include – after having asked EP Legal Service to provide a quick analysis and overview of judgments in question – at one of the upcoming INTA meetings (ideally on 25-26 October) an exchange of views on the consequences of the General Court’s recent judgements in Case T-279/19 and the Joined Cases T-344/19 and T-356/19 annulling Council Decisions (EU) 2019/217 and (EU) 2019/441.*

**18. Any other business**

**Decision:** *To try to organize in the margins of the ad hoc delegation to the WTO 12th Ministerial Conference also a bilateral meeting with Swiss authorities on EU-Switzerland trade relations.*
