2.3. INTA input to the Joint Communication on "Renewed Partnership for the Southern Neighbourhood: a new Agenda for the Mediterranean"

Decision: *To reiterate a general opposition to AFET increasingly attempting to use Rule 118 for broader strategic and policy issues (where Rule 54 report should be used, allowing for formal opinions and 'associated committee' status where applicable), but exceptionally and in the spirit of good cooperation with AFET not to object to this Rule 118 resolution, provided that AFET would fully respect INTA's competences by limiting its draft resolution and amendments to matters falling strictly within AFET's competences and by ensuring that any economic and trade elements of the resolution would be strictly limited to those submitted by INTA in the form of a letter; the Chair to engage with AFET Chair and the Coordinators to engage with their AFET counterparts to that effect.*

2.4. Ban on forced labour products

Decision: *To organise as soon as possible a technical briefing on the ban of forced labour products (inviting US experts to share their similar experience and the Commission) and to have a discussion at the Committee after the proposal is published.*

2.5. Gender mainstreaming in the work of INTA Committee

Decision: *While recognizing the importance of gender mainstreaming in trade policy and building upon the 'INTA Action Plan on Gender Mainstreaming 2019-2024', to reconfirm its general commitment to gender equality and importance of awareness-raising, to reiterate that for hearings and workshops the gender balance of invited experts and guest speakers should be taken into account to the maximum extent possible, and – where applicable and to the extent possible – to suggest the following guidance: (i) gender aspect should be an integral part of committee debates and the Commission representatives could be asked to address the gender dimension; (ii) meetings with women organisations could be included in the INTA ad-hoc delegations programmes; and (iii) INTA Standing Rapporteurs are invited to include a gender specific discussion in one of their upcoming Monitoring Group meetings.*
