## **1.2 Budget 2021 – updated information on the budgetary procedure**

The deadline for budgetary amendments will be set on 16 July at 12:00. This will allow ITRE Members to table amendments and propose Pilot Projects and Preparatory

Actions. Amendments need to be tabled in English only, and ideally be tabled on behalf of political groups.

Should a Council position be available before the vote on 1 September, the Rapporteur would aim for a vote on the necessary 'restore DB' amendments, preparation time permitting. If this would not be possible, BUDG would need to ensure that those 'restore DB' amendments are tabled by the BUDG Rapporteur.

If political developments make additional budgetary amendments necessary, Members are invited to table amendments with co-signature of a BUDG Member by 3 September 12:00 directly in BUDG.

Should in the course of the summer the deadlines be postponed by BUDG, ITRE would open a second deadline for amendments (probably early September) to react to latest developments. The amendments tabled by 16 July would remain valid.

The ITRE opinion will only be drafted early September once a clear picture of the Council position is available. Amendments will need to be drafted in English only, with a vote in ITRE early October.

### **1.3 Evaluation of remote voting in ITRE and future steps**

The Committee will continue using its current remote voting system for the upcoming votes scheduled until early September. The Coordinators will reconsider the situation in September.
