1.1 REFERRALS/ATTRIBUTIONS

Legislative opinions

1.1.1 Proposal for a regulation of the European Parliament and of the Council on information security in the institutions, bodies, offices and agencies of the Union COM(2022)0119

The opinion was allocated to EPP for 1 point, with a view to being dealt with by the same team of Rapporteur and Shadows as for the proposal for a regulation laying down measures for a high common level of cybersecurity at the institutions, bodies, offices and agencies of the Union (COM(2022)0122).

1.1.2 Proposal for a directive of the European Parliament and of the Council amending Directive 2010/75/EU of the European Parliament and of the Council of 24 November 2010 on industrial emissions (integrated pollution prevention and control) and Council Directive 1999/31/EC of 26 April 1999 on the landfill of waste COM(2022)0156

The opinion was allocated to EPP for 1 point.

1.1.3 Proposal for a regulation of the European Parliament and of the Council on the financial rules applicable to the general budget of the union COM(2022)0223

The Committee will draw up an opinion in the form of a letter specifically focused on decommitment rules.

1.2 Committee working regime

The following specific regime will apply in ITRE, subject to reassessment of the hybrid modalities by end 2022:

Committee meetings

- I. The Chair will decide in specific cases whether to hold a Committee meeting or part of a Committee meeting only in physical presence. In other cases, and until otherwise decided by Coordinators representing a majority of Committee Members, Committee meetings, public hearings and workshops, meetings with national parliaments and exchanges of views with external speakers would be conducted in hybrid mode, in order to enable participation of Members who, for reasons beyond their control, cannot attend in person.
- II. Speakers' lists will continue to be used. Members present in the room will be given priority in speaking time under the catch-the-eye.

Coordinators' meetings

- III. Regular in camera Coordinators' meetings shall take place in physical presence. Coordinators' meetings open to all Members may take place fully remotely.

Shadow meetings and working group meetings

- IV. Non-public informal committee-related activities, such as shadow meetings, working group meetings or technical meetings, should be organised in a way enabling the meeting to take place in a timely and efficient manner.

1.3 ITRE mission to Poland

This mission will be considered when the Coordinators decide on the ITRE missions for 2023.

1.4 Extension of the mandate of the ITRE Contact Group on Ukraine

The mandate was extended for an indefinite period depending on the geopolitical situation, with meetings organised as need arises in light of developments.

1.5 ITRE opinion on the REPowerEU proposal amending the Recovery and Resilience Facility

Due to time constraints, work should be in English only. The ITRE internal deadline for tabling compromise amendments will be four working days before the vote in Committee.
