**3. Examination of potential or actual conflict of interests of the Commissioners-designate**

**Decisions:**

The committee have continued to conduct the assessment of potential or actual conflict of interest of Commissioners-designate pursuant to Article 2 of Annex VII of the Rules of Procedure.

With regards to the assessment of potential or actual conflict of interests concerning the following Commissioners-designate: Ms Margrethe Vestager, Mr Valdis Dombrovskis, Mr Maroš Šefčovič, Ms Dubravka Šuica, Mr Margaritis Schinas, Mr Phil Hogan, Ms Mariya Gabriel, Mr Nicolas Schmit, Ms Helena Dalli, Mr Paolo Gentiloni, Mr Frans Timmermans, Ms Ylva Johansson, Ms Kadri Simson, Mr Janez Lenarčič and Ms Jutta Urpilainen, the committee decided that it is satisfied and concluded the assessment.

Pursuant to Article 2(3)(b) of Annex VII, the committee then considered and properly analysed the replies provided on 24 September 2019 to its requests for supplementary information of 20 September 2019 by the following Commissioners-designate: Mr Josep Borrell Fontelles, Ms Věra Jourová, Ms Elisa Ferreira, Ms Stella Kyriakides, Mr Didier Reynders, Ms Sylvie Goulard, Mr Virginijus Sinkevičius, Mr Janusz Wojciechowski, Mrs Rovana Plumb, Mr Johannes Hahn. The Committee decided that it is satisfied and concluded the assessment of the potential or actual conflict of interests with regards to the following Commissioners-designate: Mr Josep Borrell Fontelles, Ms Věra Jourová, Ms Elisa Ferreira, Ms Stella Kyriakides, Mr Didier Reynders, Ms Sylvie Goulard, Mr Virginijus Sinkevičius.

With regards to Case T-511/19, *Staciwa v Commission* - Objection of illegality of Article 12, paragraph 2, of Annex VIII to the Staff Regulations - Possible intervention of the European Parliament, the committee decided by 18 votes in favour, 0 votes against and 2 abstentions, to intervene before the General Court in order to defend the validity of the above-mentioned provision.

With regards to Case C-481/19 *Consob* – Market abuse – Obligation to cooperate with the investigating authority – Rights of defence – Directive 2003/6/EC of the European Parliament and of the Council – Regulation (EU) No 596/2014 of the European Parliament and of the Council – Validity – Possible submission of observations by the European Parliament, the committee decided by 17 votes in favour, 0 votes against and 3 abstentions, to submit observations in the proceedings before the Court of Justice in accordance with the recommendation.

With regards to case European Labour Authority - Decision-making power as regards the location of the seat - Regulation (EU) 2019/1149 of the European Parliament and of the Council - Decision (EU) 2019/1199 of the representatives of the governments of the Member States - Possible action by the European Parliament, the committee decided by 18 votes in favour, 2 votes against and 1 abstention, to bring an action against the above-mentioned Decision.

**11. Examination of potential or actual conflict of interests of the Commissioners-designate**

**Decisions:**

The Committee have continued to conduct the assessment of potential or actual conflict of interest of Commissioners-designate pursuant to Article 2 of Annex VII to the Rules of Procedure.

Pursuant to Article 2(3)(b) of Annex VII, the Committee held a discussion first with Commissioner-designate Rovana Plumb and subsequently with Commissioner-designate László Trócsányi. Each of the discussions was followed by extensive debate.

Pursuant to Article 2(3)(c) of Annex VII, the Committee took the following decisions with regards to Commissioner-designate Rovana Plumb:

The Committee decided by 15-6-2 of the existence of a conflict of interest. Subsequently, the committee rejected by 8-12-2 a possibility to draw up a recommendation aiming at resolving the conflict of interest either by resolving the issue of the financial interest in question or by change to the portfolio. Subsequently, the committee decided by 20-0-2 that the President-elect of the Commission should be informed that, as it stands there is a conflict of interest and until that conflict is resolved, the candidate cannot exercise the role of a Commissioner for the portfolio proposed and of the need to solve this issue, but without prescribing a possible solution to the President-elect.

Pursuant to Article 2(3)(c) of Annex VII, the Committee took the following decisions with regards to Commissioner-designate László Trócsányi:

The committee decided by 11-9-2 of the existence of a conflict of interest. Subsequently, the committee rejected by 5-16-1 a possibility to draw up a recommendation aiming at resolving the conflict of interest by change to the portfolio. Subsequently, the committee decided by 17-2-2 that the President-elect of the Commission should be informed that, as it stands there is a conflict of interest and until that conflict is resolved, the candidate cannot exercise the role of a Commissioner for the portfolio proposed and of the need to solve this issue, but without prescribing a possible solution to the President-elect.

Pursuant to Article 2(3)(b) of Annex VII, the committee then considered and properly analysed the reply provided by Commissioner-designate Janusz Wojciechowski on 25 September 2019 to its requests for supplementary information of the same date. It decided that it is satisfied and concluded the assessment of potential or actual conflict of interest with regards to the Commissioner-designate in question.

Finally, the Committee considered the reply provided on 26 September 2019 by Commissioner-designate Johannes Hahn to the Committee's recommendation of 25 September 2019. Since the Commissioner-designate informed that he agreed with the recommendation of the Committee, the Committee decided that it is satisfied and concluded the assessment of potential or actual conflict of interest with regards to the Commissioner-designate in question.

On that basis, the Committee is to communicate to committees responsible for the hearings the results of the assessment of conflict of interests before 27 September in order for the hearings to start on 30 September as planned. The President of the Parliament is to be informed about the decisions concerning Commissioners-designate Rovana Plumb and László Trócsányi.
