## 2.4. Delegated and Implementing Acts

### 2.4.1. Delegated Acts:

On 21 August 2023, the Commission sent to the Parliament the following delegated acts:

– COMMISSION DELEGATED REGULATION (EU) of 18.08.2023 amending Delegated Regulation (EU) 2016/1675 to add Cameroon and Vietnam to the list of high-risk third countries, C(2023)5552 under Article 9(2) of Directive (EU) 2015/849 (AMLD), and its Annex.

An internal deadline for objection was set for 11 September 2023 cob. Members were informed via CJ12 joint ECON-LIBE email on 23 August 2023 and via the LIBE DIA Newsletter of 25 August 2023.

– COMMISSION DELEGATED REGULATION supplementing Directive (EU) 2022/2557 of the European Parliament and of the Council by establishing a list of essential services (Basic Act: Essential services Directive).

– COMMISSION DELEGATED DECISION specifying the content and format of the questions and laying down the additional set of predetermined questions for the European Travel Information and Authorisation System (ETIAS) pursuant to Articles 17(5) and (6) of Regulation (EU) 2018/1240 of the European Parliament and of the Council (and its annex). (Basic Act: ETIAS Regulation)

An internal deadline for objection was set for 6 September 2023 cob. Members were informed via email on 23 August 2023 and via the LIBE DIA Newsletter of 25 August 2023.

### 2.4.2. Implementing Acts:

On 10 August 2023, the Commission sent to the Parliament the following draft implementing act:

– Draft COMMISSION IMPLEMENTING DECISION amending Implementing Decisions C(2021) 2583 and C(2022) 8588 as regards support to the Council of Europe for a project combating anti-LGBTIQ violence and hate speech and strengthening awareness-raising and fact-based narratives about LGBTIQ persons (and its annex). (Basic Act: CERV Regulation).

On 20 July 2023, the Commission sent to the Parliament the following implementing acts:

– Draft COMMISSION IMPLEMENTING DECISION setting out the list of supporting documents to be submitted by applicants in Egypt for short stay visas and repealing Implementing Decision C(2012) 1152 (and its annex). (Basic Act: VISA Code Regulation).

– Draft COMMISSION IMPLEMENTING DECISION setting out the list of supporting documents to be submitted by applicants in Jordan for short stay visas and repealing Implementing Decision C(2012) 1725 (and its annex). (Basic Act: VISA Code Regulation).

– Draft COMMISSION IMPLEMENTING DECISION setting out the list of supporting documents to be submitted by applicants in Kenya for short stay visas and repealing Implementing Decision C(2012) 6146 (and its annex). (Basic Act: VISA Code Regulation).

On 18 July 2023, the Commission sent to the Parliament the following implementing acts:

– Draft COMMISSION IMPLEMENTING DECISION laying down detailed rules on the functionality for the centralised management of the lists of authorities accessing the Entry/Exit System and the Visa Information System. (Basic Acts: Convention Implementing the Schengen Agreement and Regulation, EES and VIS Regulations). Members were informed via email on 23 August 2023 and via the LIBE DIA Newsletter of 25 August 2023.

On 20 July 2023, the Commission sent to the Parliament the following draft implementing act:

– Draft COMMISSION IMPLEMENTING DECISION amending Annex II to Implementing Decision C(2014) 6146, as regards the list of supporting documents to be submitted by applicants for short stay visas in Kenya (and its annex). (Basic Act: VISA Code Regulation).
