following the delegation of the Committee on Fisheries to the 46th session of the General Fisheries Commission for the Mediterranean (GFCM), Split, Croatia, 6–8 November 2023

Introduction

The 46th session of the General Fisheries Commission for the Mediterranean (GFCM) of the Food and Agriculture Organization of the United Nations (FAO) was held in Split, Croatia, from 6 to 8 November 2023. The session was chaired by Mr. Roland Kristo, GFCM Chairperson, and attended by delegates from 20 contracting parties, 3 cooperating non-contracting parties, representatives of 12 intergovernmental and non-governmental organizations, and the GFCM Secretariat.

This was the second time that a delegation of the European Parliament attended a GFCM annual session after last year's meeting in Tirana, Albania. Mr Ladislav ILČIĆ (ECR), and Ms Caroline ROOSE (Verts/ALE) joined as observers the delegation of the European Union. The mission programme included, next to the participation to the plenary session, bilateral meetings with GFCM Executive Secretary Miguel Bernal, EFCA, environmental NGOs, and the European Commission.

The GFCM unanimously adopted a total of 34 common measures. In addition, the EU will support the implementation of the GFCM's 2030 measures and strategy with an annual grant of €8 million. The most noteworthy decisions agreed by the GFCM Commission concerned the creation of a system of sanctions to combat overfishing and illegal fishing in the Mediterranean, which will allow to take measures against countries which engage in overfishing or illegal, unreported and unregulated (IUU) fishing.

Two binding recommendations adopted by the GFCM plenary will allow to "implement appropriate corrective measures to deter non-compliance". According to the newly adopted text, the GFCM Secretariat will carry out a compliance assessment scheme for each CPC concerned, which should include the evaluation of the level of severity of each individual case of non-compliance, taking into account the mitigating or aggravating

circumstances.

Also, new catch documentation systems for red coral in the Mediterranean and for turbot in the Black Sea will help identify the origin of fishery products, ensuring better conservation of these emblematic species.

Meetings

Debriefings with the European Commission

As it is customary during meetings of Regional Fisheries Management Organisations, the Head of the EU delegation, Ms. Valerie Lainé, DG MARE Head of Unit for Fisheries Management Mediterranean & Black Sea held two debriefings with the Members of the European Parliament giving account of the state of the ongoing discussions.

Mrs Lainé highlighted the politicization underlying GFCM negotiations, caused mainly by the increasingly conflictual geopolitical context in the Mediterranean and in the Black Sea (Ukraine war, Gaza crisis).

Meeting with EFCA, Neil Ansell, Head of Sector Mediterranean Sea and International Waters of the European Fisheries Control Agency (EFCA)

Members welcomed a meeting with the European Fisheries Control Agency to discuss control issues specifically related to the Mediterranean, notably how to ensure a level playing field in the Mediterranean between EU and third country fishing fleets.

As the most debated decisions in GFCM concerned compliance, EFCA's role is bound to become more relevant in monitoring and detecting infractions. With regard to Vessel Monitoring Systems (VMS), only EU vessels of 15 m and above are under the obligation of VMS reporting. It is therefore more difficult to locate vessels from third countries. EFCA recognises that a regional VMS scheme would facilitate targeted inspections and save money. Meanwhile measures regarding sighting are helpful. EFCA follows up on every potential non-compliance report and communicates it to GFCM.

Members also held a meeting with representatives of environmental stakeholders' organisations, represented by Marco Costantini, Regional Manager on Fisheries WWF

Mediterranean Marine Initiative, Domitilla Senni, Director of Medreact, Vanya Vulperhorst, OCEANA Policy advisor, and Johannes Müller from Oceancare.

NGOs had called for an increased transparency and an effective tackling of non-compliance cases and IUU fishing.

Members also attended the screening of a documentary on the "Jabuka-Pomo" Fisheries Restricted Area in the Adriatic Sea, which detailed the progress in terms of stock recovery and underlined the acceptance by the fishers' communities since the establishment of the FRA.

Meeting with Miguel Bernal, GFCM Executive Secretary

In their meeting with GFCM Executive Secretary Miguel Bernal, Members reiterated the interest of the Committee on Fisheries. They addressed issues such as Fishing Restricted Areas, management plans for small pelagics and new aquaculture techniques.

The GFCM Secretary General mentioned the upcoming report on Mediterranean and Black Sea Fisheries (expected on 7 December) and pointed out to future key events such as the new ministerial declaration on fishing in the Mediterranean, a follow up to the "MedFish4Ever" declaration of 2017.

SUMMARY OF GFCM DECISIONS:

The GFCM adopted 34 measures, 28 of which had been presented by the European Union, for the management and control of fisheries, aquaculture and the protection of sensitive habitats in the Mediterranean and Black Sea.

Among the main measures, it was agreed to launch new tools to keep track of the activities of all fleets fishing in the Mediterranean and the Black Seas and sharing the various multiannual management plans (MAPs). The new mechanism will follow up on cases of non-compliance through appropriate and proportionate measures. To consolidate joint efforts in the Mediterranean and make sure the measures deliver on the ground, a European Fisheries Control Agency (EFCA) patrol vessel will be deployed permanently still this year.

Adopted resolutions on compliance aim to reinforce the level playing field in control and management of fisheries in the Mediterranean and the Black Seas. This is an important step in ensuring that all operators involved in fisheries follow the same standards, based on the principles of the Common Fisheries Policy.

The EU will support the implementation of the measures and the GFCM 2030 Strategy

with an annual grant of €8 million. New catch documentation schemes for red coral in the Mediterranean and for turbot in the Black Sea will help to identify the origin of fish products, ensuring better conservation of these iconic species.

Furthermore the GFCM will be the first regional fisheries management organisation to establish a permanent working group and to adopt a roadmap for the decarbonisation of fishing activities. This working group will identify actions to promote a more resilient sector against energy crises, a reduction of the carbon footprint and studies to assess the impact of the fishing gear on the seabed.


A new multiannual management plan (MAP) for common dolphinfish in the Mediterranean Sea was adopted based on a joint EU-Tunisia proposal, the main players in this fishery.

Following a proposal from the EU, the GFCM adopted a strategy to protect vulnerable species and launched an Observatory for non-indigenous species. CPCs agreed on a phased implementation of 4 subregional pilot studies towards evaluating the impacts of the potential extension of the limits of the current bottom trawling ban from 1 000 m to 800 m in the Mediterranean Sea on the fisheries concerned.

Despite opposition from Egypt GFCM also consolidated the existing measures under the multiannual management plan for European eel. Long-term measures will be determined next year, based on the results of a regional research programme. With regard to compliance, the issue of eel conservation lead to intense discussions, with Egypt denouncing the impracticability of the EU proposed recommendation for a long-term management plan for European eel due to the inclusion of freshwaters and transitional brackish waters, such as lagoons and estuaries, within the scope of this recommendation. In line with measures adopted in previous years, GFCM decided to reinforce the fisheries restricted area (FRA) in the Gulf of Lion by protecting spawning aggregations and deepsea sensitive habitats. EU, Morocco and Algeria agreed to implement a FRA in the Cabliers Coral Mound in the Alboran Sea.
