2.2 INI-Reports

Art. 2 of the Decision of the Conference of Presidents of 12.12.2002, last amended on 15.07.2016, states that “*during the first half of a parliamentary term, each parliamentary committee may simultaneously draft up to six own-initiative reports*”. Proposals adopted by Coordinators have to be authorized by the CCC/CoP.

Decision: Groups are invited to submit proposals for own-initiative reports (legislative/non-legislative/implementation reports) by 17 September, so that they can be discussed and approved at the meetings of 24 September or 2 October.

Decision: Coordinators agreed to make an opinion on this discharge file; a decision on attribution will be taken at the next meeting.

2.3.2 2018 Discharge: General Budget - European Commission
2019/2055(DEC)

Decision: *No opinion.*

3. **Hearing of Commissioner-designate**

A list of 30 questions received by the Secretariat was circulated. Coordinators may choose five specific questions to be submitted in writing to the Commissioner-designate for Fisheries. In case the hearing is to be held jointly with another Committee, only 3 written questions per Committee will be allowed. During the Commissioner-designate's hearing, a maximum of 25 oral questions will be allowed (i.e. 12 questions each in case of joint hearing).

Decision: *Coordinators are invited to make a first selection ASAP; a meeting of the Secretariat with Group advisors on Friday 6 September should try to identify a shortlist of questions, so that the final list of five written questions can be agreed by written procedure by Wednesday next week.*

5. **Delegated and implementing acts**

5.1. Delegated Acts under scrutiny

Three Delegated Acts are currently under scrutiny:

- **Delegated Regulation on the implementation of the Union's international obligations under ICCAT and the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries**

This act was adopted by the Commission on **18 July 2019** and Members have received a specific briefing note from the Secretariat.

Decision: *Coordinators decided unanimously to request for this Delegated Act an extension of the scrutiny deadline by two months, as the current deadline to object would expire on 18 September 2019.*

- **Delegated Regulation establishing a discard plan for Venus shells in certain Italian territorial waters**

This act was adopted by the Commission on **28 August 2019**. Parliament has two months to object to it, i.e. until **28 October 2019**.

- **Delegated Regulation establishing a discard plan for certain demersal fisheries in the Mediterranean Sea**

This act was adopted by the Commission on **29 August 2019**. Parliament has two

months to object to it, i.e. until **29 October 2019**.

Decision: The Coordinators took note of these two Delegated Acts under scrutiny; a further discussion on eventual actions will take place at the next meeting.

5.2. Implementing acts under preparation

Coordinators took note of the implementing act under preparation.

6. Missions & Delegations

6.1 Missions in the 2nd half of 2019

6.1.1. Mission to Vigo/EFCA, Spain - 28-30 October 2019

A draft programme was elaborated by the Secretariat and the Groups have proposed their participants (*Annex I*). The authorization by the CoP/Bureau is still pending.

*Decision: The Coordinators took note of the draft programme and adopted the final list of participants in **Annex I**.*

6.1.2. ICCAT 26th Annual Meeting - Palma de Mallorca, Spain - 23-25 November 2019

A draft programme will be presented at the next meeting (depending on ICCAT secretariat). The authorization by the CoP/Bureau is still pending.

Decision: The programme and list of participants will be adopted at the next meeting.

6.2 Missions in the 1st half of 2020

Coordinators are reminded to submit proposals for missions in 2020 to the Secretariat by 19 September. A decision needs to be taken on 2 October. (NB: no need to send again proposals already submitted!)

7. Public Hearings

7.1 Hearings in November/December 2019

*Decision: The Coordinators approved the two hearings proposed by the political Groups in **Annex II** to be requested for the 2nd half of 2019.*

The IPCC report on “The Ocean and Cryosphere in a changing climate” will be presented in Committee in October.

7.2 Hearings in the 1st half of 2020

Coordinators are reminded to submit proposals for public hearings in the 1st half of

2020 to the Secretariat by 19 September. A decision needs to be taken on 2 October.

8. Any other business

8.1 Petitions Network

Decision: Coordinators designated the 1st Vice-Chair Peter VAN DALEN as PECH liaison to the EP Petitions Network coordinated by PETI Committee. The Secretariat will inform the PETI Committee accordingly.

8.2 Gender Mainstreaming Network

In order to implement gender mainstreaming in its activities, the EP has decided in 2013 that each Committee should appoint two Members (permanent/substitute, possibly male/female) responsible for gender mainstreaming; they will form part of the Gender Mainstreaming Network coordinated by FEMM Committee (*see letter in Annex III*)

Decision: Ms AVRAM was proposed by the S&D Group; Groups may propose other candidates ahead of the next meeting.

8.3 Brexit

On 4 September the Commission adopted a Brexit-related contingency proposal for a “Regulation amending Regulation (EU) 2017/2403 as regards fishing authorisations for Union vessels in United Kingdom waters and fishing operations of United Kingdom fishing vessels in Union waters” COM(2019)0380 final, to be discussed at the next meeting.

As was done in the past term, Groups may appoint a Member as contact person for Brexit-related issues.

8.4 Items on next PECH Committee agenda

The Chair informed the Coordinators on items to be included in future Committee agendas (Brexit, ICES).
