**1. Chair's announcements**

The Chair informed on the cancellation of the planned mission to Vigo/EFCA (*see item 6.1.*); he also invited Coordinators, if they so wished, to contact him for proposals of matters to be added to future PECH Committee meeting agendas.

**2. Decisions on procedure**

**2.1. Reports**

#### **5. Delegated and implementing acts**

##### **5.1. Delegated Acts under scrutiny**

**Four new Delegated Acts** (n.1-4) were adopted on **1 October 2019**, with a deadline to object on **1 December 2019**. Technical Notes by the Secretariat will follow ASAP.

In total, seven Delegated acts are currently under scrutiny:

1. Delegated Regulation specifying details of implementation of the **landing obligation for certain demersal fisheries in the North Sea** for the period 2020-2021
2. Delegated Regulation specifying details of the **landing obligation for certain demersal fisheries in North-Western waters** for the period 2020-2021
3. Delegated Regulation specifying details of the **landing obligation for certain demersal fisheries in South-Western waters** for the period 2020-2021
4. Delegated Regulation supplementing Regulation (EU) 2019/1241 with detailed rules for the implementation of **real-time closures for Northern prawn fisheries in the Skagerrak**
5. Delegated Regulation **on the implementation of the Union's international obligations under ICCAT and the Convention on Future Multilateral Cooperation in the Northwest Atlantic Fisheries**

Presented in Committee on 4 September; Parliament requested the extension of the deadline until **18 November 2019** to formulate any elements of objections, if needed.

6. Delegated Regulation **establishing a discard plan for Venus shells in certain Italian territorial waters**  
Presented in Committee on 4 September; deadline to object is **28 October 2019**.
7. Delegated Regulation **establishing a discard plan for certain demersal fisheries in the Mediterranean Sea**  
Presented in Committee on 4 September; deadline to object is **29 October 2019**.

Decision: *The Coordinators took note of the Delegated Acts under scrutiny and decided to request the extension of the deadline for scrutiny by two months for Delegated Acts n. 6 and 7.*
