1. Chair's announcements

The Chair proposes to hold a Committee meeting in which the Commission should present the newly adopted EU Strategies on Biodiversity and “Farm to fork (F2F)” with an assessment of the implementation of the Marine Strategy Framework Directive. As the proposed date of 8 June (International Oceans Day) is not available, it could take place on 11 June afternoon (16.45-18.45).

2. Procedure

- 2.1 **Opinion** to the own-initiative report by AGRI & ENVI Committees (art 58: Joint Committee) on the “**Farm to Fork**” strategy (CCC authorization still pending)
- 2.2 **Opinion** to the (likely) own-initiative report by ENVI Committee on the “**EU biodiversity strategy 2030**”
- 2.3 **Opinion** to the own-initiative report by ITRE on the “**New Industrial Strategy for Europe**” COM(2020) 102 final *(as proposed by S&D Coordinator)*

Decision: *Coordinators decided to request opinions to these 3 INI reports, but to attribute them in the next meeting. (NB: However, concerning 2.3., ITRE plans a vote already on 15 July, which would make it impossible to adopt a normal opinion, possibly a PECH position in letter format).*

3. Documents received for information

- 3.1. Proposal for a Council Decision **establishing the position to be adopted on behalf of the European Union in the Joint Committee established by the Agreement on the withdrawal of the United Kingdom from the European Union** *(NB: this refers to the assessment of how the Withdrawal Agreement is implemented, not to the future Trade agreement under negotiation)*
COM(2020) 195 final 2020/0079 (NLE)

Decision: *No action.*

4. Delegated and implementing acts

- 4.1. **Delegated Acts**

Delegated Regulation of 27.4.2020 amending Commission Delegated Regulation (EU) 2020/124 as regards certain provisions of, and Annexes to, the conservation and enforcement measures of the Northwest Atlantic Fisheries Organisation (NAFO) C(2020) 2561 final

Deadline to object: 27 June 2020.

Decision: The Coordinators took note of the Delegated Act under scrutiny.

4.2. **Implementing Acts**

The list of implementing acts is distributed.

The Coordinators took note of the Implementing Acts under preparation.

5. **Missions & Delegations**

No indication from the EP Governing bodies on the possibility to organize missions in the September to December period.

Decision: The Coordinators agreed to request authorization from the Bureau for the mission to the ICCAT 2020 Annual conference (4 MEPs + Chair) planned in Antalya/Turkey in week 48, provided it is confirmed and travel is possible.

6. **Hearings**

As for missions, no indication yet from the EP Governing bodies on the possibility to hold public hearings in the 2nd half of the year.

Decision: The Coordinators agreed that, while it is unlikely that hearings in the classic format will be authorized soon, it should be explored with the Bureau whether inviting experts via remote link will be possible for INI files to be discussed in the autumn.

7. **Any other business**

7.1. **Petitions (for information)**

Petition No 0993/2019 **on the control of engine power in fishing vessels (Annex I) - no action.**

Coordinators took note of the petition.

7.2. First Vice Chair Peter Van Dalen suggested to include in the Agenda of the next Committee meeting an exchange with the ICES experts who drafted the latest ICES Study on electric pulse fishing; he also suggested to forward the Bellamy opinion to AFET and INTA Chairs with a letter duly underlining the importance of the fisheries agreement in the context of the future EU/UK Trade Agreement.
