4. Delegated and implementing acts

4.1. Delegated Acts under scrutiny

The following Delegated Acts, adopted by the Commission in August, are currently under scrutiny:

1. Delegated Regulation of 5.8.2020 amending Delegated Regulation (EU) 2018/161 establishing a “*de minimis*” exemption to the landing obligation for certain small pelagic fisheries in the Mediterranean Sea, as regards its period of application
2. Delegated Regulation of 13.8.2020 amending Delegated Regulation (EU) 2020/3 as regards the derogation for the minimum conservation reference size of Venus shells (*Venus* spp.) in certain Italian territorial waters
3. Delegated Regulation of 21.8.2020 specifying details of the implementation of the landing obligation for certain fisheries in the North Sea for the period 2021-2023
4. Delegated Regulation of 21.8.2020 specifying details of the implementation of the landing obligation for certain fisheries in Western Waters for the period 2021-2023

5. Delegated Regulation of 21.8.2020 amending Delegated Regulation (EU) 2019/1241 as regards **technical measures for certain demersal and pelagic fisheries in the North Sea and in the South Western Waters**
6. Delegated Regulation of 28.8.2020 amending Delegated Regulation (EU) 2019/2238 as regards **high survivability and de minimis exemptions applicable to certain demersal fisheries in the North Sea**
7. Delegated Regulation of 28.8.2020 correcting Delegated Regulation (EU) No 1394/2014 establishing a **discard plan for certain pelagic fisheries in South-Western waters**

Deadline to object: two months after the official notifications, i.e. **21/24/31 October**.

Decision: The Coordinators took note of the Delegated Acts under scrutiny and in particular of the reserve of S&D Group concerning D.A. n. 2, which may be further analysed and discussed in a subsequent meeting. The technical Notes by the Secretariat are to be circulated before any formal decision is taken.

4.2. **Implementing Acts**

The list of implementing acts has been circulated.

5. **Hearings**

5.1 Hearings on “**Rebuilding fish stocks in the Mediterranean: next steps**” and “**Co-management of EU fisheries at local level**”

Both hearings had already been authorized by the Governing Bodies and were originally planned for 28 April and 24 June 2020. Unless objections are raised, they could be planned in remote mode for the 26/27 October and 2/3 December meetings.

Decision: The Coordinators agreed with the hearing dates proposed.

6. **Studies**

6.1 The following topics for studies/projects were proposed by Groups:

1. *“Impact assessment on the socioeconomic consequences of the biodiversity strategy for the fisheries sector” (S&D)*
2. *“State of play for farmed fish welfare and the environmental consequences of production” (Greens/EFA)*
3. *Potential of digitization, Artificial Intelligence, automation and robotics in the fisheries sector as a driving force for young people (Renew)*

Depending on available resources, the Policy Department will assess the feasibility to

commission such additional studies, either during the current 2020 planning or the 2021 planning period.

Decision: The Coordinators agreed to identify as a priority the study proposal n. 1. The exact title and scope should however be further defined at technical level by policy advisors and the Policy Department, in view of a formal adoption of the study proposal by Coordinators at a later meeting.

7. Any other business

7.1 “Brexit Adjustment Reserve”

The Chair proposed a brief discussion on the new € 5bn “Brexit Adjustment Reserve”¹ and on the high risk of a no-deal exit by the UK at the end of the transition period on 31.12.2020

Decision: The Coordinators agreed to hold an “in camera” meeting with the relevant Commission services to discuss the focus and scope of the Brexit Adjustment Reserve and any “Plan B” regarding the consequences for fisheries of a no-deal Brexit.

7.2. Use of iVote for upcoming votes in Committee

Before the summer break, several committees started using an application called “iVote” as **a temporary solution for remote voting in committees**. iVote only works on Apple devices (iPads and iPhones) and has proved to cope with long and complex voting lists, including compromise AMs and secret votes.

For the moment, the votes planned in PECH can be handled with the paper ballot system, but larger votes (such as for the Control file, planned for vote in November) a solution allowing safe and fast remote voting at committee level, needs to be applied.

Possibly DG ITEC comes up before November with a new permanent voting application; if not, iVote could be used as a provisional solution.

In any case, Coordinators have to agree on the use of iVote in Committee.

Decision: The Chair will liaise with other Chairs currently using iVote to assess its functionality and eventually propose an iVote-test with Members (unless DG ITEC comes up with a new general application for remote voting by October).

7.3 ICCAT Annual conference 2020

The Chair informs that the 2020 ICCAT Annual conference, planned for the end of November in Antalya/Turkey, has been cancelled.

7.4 **EU-Greenland FPA**
