4. Delegated and implementing acts

4.1. Delegated Acts under scrutiny

These Delegated Acts were already presented by the Commission on 1 September with a subsequent debate by Coordinators on 3 September.

Technical notes elaborated by the Secretariat were forwarded to Members in week 37.

- Delegated Regulation of 5.8.2020 amending Delegated Regulation (EU) 2018/161 establishing a **“*de minimis*” exemption to the landing obligation for certain small pelagic fisheries in the Mediterranean Sea**, as regards its period of application
- Delegated Regulation of 13.8.2020 amending Delegated Regulation (EU) 2020/3 as regards the **derogation for the minimum conservation reference size of Venus shells (*Venus* spp.) in certain Italian territorial waters**
- Delegated Regulation of 21.8.2020 specifying details of the **implementation of the landing obligation for certain fisheries in the North Sea for the period 2021-2023**
- Delegated Regulation of 21.8.2020 specifying details of the **implementation of the landing obligation for certain fisheries in Western Waters for the period 2021-2023**
- Delegated Regulation of 21.8.2020 amending Delegated Regulation (EU) 2019/1241 as regards **technical measures for certain demersal and pelagic fisheries in the North Sea and in the South Western Waters**
- Delegated Regulation of 28.8.2020 amending Delegated Regulation (EU) 2019/2238 as regards **high survivability and *de minimis* exemptions applicable to certain demersal fisheries in the North Sea**
- Delegated Regulation of 28.8.2020 correcting Delegated Regulation (EU) No 1394/2014 establishing a **discard plan for certain pelagic fisheries in South-Western waters**

Deadline to object is two months after the official notification: **21/24/31 October**.

Decision: *The S&D Group reiterated its concern concerning D.A. nr.2 and informed that some time was still needed for a complete assessment. A final decision on any action should be taken at the next meeting (12 October), the last one before the deadline.*

4.2. **Implementing Acts**

The list of implementing acts was circulated.

5. **Any other business**

5.1. Experts for INI debate (by visioconference)

Ms Chabaud (Renew) rapporteur for the INI report “The impact on fisheries of marine litter” requested for two experts to intervene in remote during the presentation scheduled

for 26/27 October: Marie Laure Barois-Bougier (ReSeacIons) and Francois Galgani (scientist at Ifremer).

Decision: The Coordinators approved the request, highlighting however their concern for a more transparent and inclusive process to be applied for similar cases, in order to allow for balanced debates. In this context, Ms Conte informed that she would invite the other Groups to choose an expert for the presentation of her INI report (scheduled for December).

5.2. Update on iVote application (for info)

The Chair informed that DG ITEC is testing a new interface that would allow Members to vote in remote without being limited to Apple products. As it should be ready by mid-October, it is proposed to proceed with email ballots for the votes taking place in September and then switch to the new application.

5.3. EP representatives to the CNML (for info)

The Chairs of ENVI/PECH/TRAN Committees found an agreement on the two Members to be appointed to the Board of the CNML (National Council of the Sea and Coastal Regions, a French consultative body), as requested earlier in the year by the CoP. Ms Chabaud (ENVI/PECH) and Ms Delli (TRAN/subst.) will replace Mr Cadec (PECH) and Mr Omarjee (TRAN/subst.). (*see Annex*).

5.4. Letter to Commissioners

The Coordinator of the Greens/EFA Group complained that the letter addressed to the Commissioners involved in the negotiations of the upcoming Fisheries Partnership Agreement with Greenland, dated 11 September, had not been circulated for validation among Coordinators, as decided at the last meeting under item 7.4. of Recommendations.
