3. Assessment of the work of the PETI committee in 2020 and possibilities for improvements for the next year (Verts/ALE request)

Coordinators agreed to apply the urgency procedure to petitions 1424/2020 and 0076/2021 (Renew request) and to include them in the agenda of March.

Coordinators agreed to include petitions 0973/2020 and 0231/2019 (Renew requests) in the agenda of April.

Coordinators agreed to submit the suggested proposals to the ECA for 2022 ECA Work Programme.

Coordinators agreed to select a maximum of two ECA's reports/audit reviews for presentation in future PETI meetings via written procedure.

8. Requests for specific action

Coordinators agreed to send a letter to the Commission regarding petition 1236/2019 (mining in Turów, PL) asking for clarification on what kind of actions the EC is going to take after it came to the conclusion that there are some infringements of EU law in this case.

Coordinators agreed to group and apply the urgency procedure to petitions 1397/2020, 1399/2020, 1401/2020, 1438/2020, 1469/2020, 1501/2020, 0046/2021. A decision whether to include them or not in a committee agenda will be taken at a later stage.

Coordinators did not agree to reopen petition 38/2020.
