1. Resumption of the session

The sitting opened at 17.00.

2. Approval of the minutes of the previous sitting

The minutes of the previous sitting were approved.

3. Statement by the President

The President made a statement condemning the murder last Wednesday in Paris of the three Kurdish activists Sakine Cansiz, Leyla Söylemez and Fidan Dogan. He informed the House that the parents, sister and brother of Fidan Dogan were present in the public gallery and expressed Parliament's condolences to the families of the three victims.

4. Composition of Parliament

The Italian authorities had given notice of the election of Rosario Crocetta as President of the Region of Sicily with effect from 17 December 2012 and the appointment of Francesca Barracciu to replace him on the same date.

In accordance with Article 7(1) of the Act concerning the election of the Members of the European Parliament by direct universal suffrage, and with Rule 4(1) and (4) of its Rules of Procedure, Parliament established the vacancy of Rosario Crocetta's seat with effect from 17 December 2012 and noted the appointment of Francesca Barracciu as a Member of the European Parliament from that date.

Under Rule 3(2), until such time as her credentials had been verified or a ruling had been given on any dispute, and provided that she had previously made a written declaration stating that she did not hold any office incompatible with that of Member of the European Parliament, Francesca Barracciu would take her seat in Parliament and on its bodies and would enjoy all the rights attaching thereto.

Frieda Brepoels had resigned as a Member of the European Parliament with effect from 31 January 2013.

Pursuant to Rule 4(1), Parliament established the vacancy with effect from that date and informed the national authorities concerned.

The authorities of the Republic of Bulgaria had given notice of the election of Preslav Borissov to replace Iliana Ivanova as Member of Parliament with effect from 1 January 2013.

Under Rule 3(2), until such time as his credentials had been verified or a ruling had been given on any dispute, and provided that he had previously made a written declaration stating that he did not hold any office incompatible with that of Member of the European Parliament, Preslav Borissov would take his seat in Parliament and on its bodies and would enjoy all the rights attaching thereto.

The authorities of the Republic of Romania had given notice the election of George Becali to the Romanian parliament with effect from 19 December 2012.

Pursuant to Rule 4(1), Parliament established the vacancy with effect from that date and informed the national authorities concerned.

The authorities of the Republic of Romania had given notice of the election of Dan Dumitru Zamfirescu as a Member of the European Parliament to replace George Becali, with effect from 9 January 2013.

Under Rule 3(2), until such time as his credentials had been verified or a ruling had been given on any dispute, and provided that he had previously made a written declaration stating that he did not hold any office incompatible with that of Member of the European Parliament, Dan Dumitru Zamfirescu would take his seat in Parliament and on its bodies and would enjoy all the rights attaching thereto.

5. Request for the waiver of parliamentary immunity

The Greek competent authorities had forwarded to the President a request for the waiver of the parliamentary immunity of Spyros Danellis in connection with legal proceedings before the Appeal Court of Crete.

Pursuant to Rule 6(2), the request had been referred to the committee responsible, the JURI Committee.

6. Verification of credentials

On a proposal from its JURI Committee, Parliament had decided to confirm the mandates of Justina Vitkauskaitė, with effect from 21 November 2012, and Monika Panayotova, with effect from 6 December 2012.

7. Composition of committees and delegations

The President had received the following requests for appointments from the EFD Group:

Delegation for relations with Israel: Preslav Borissov to replace Monika Panayotova

Delegation to the EU-Russia Parliamentary Cooperation Committee: Preslav Borissov

The appointments would be deemed ratified if there were no objections before the approval of these minutes.

- Proposal for a decision on the opening of, and mandate for, interinstitutional negotiations on the proposal for a Regulation of the European Parliament and of the Council establishing the Asylum and Migration Fund (COM(2011)0751 – C7-0443/2011 – 2011/0366(COD) – (2013/2504(RSP)) (B7-0002/2013)

- Proposal for a decision on the opening of, and mandate for, interinstitutional negotiations on the proposal for a Regulation of the European Parliament and of the Council establishing, as part of the Internal Security Fund, the instrument for financial support for police cooperation, preventing and combating crime, and crisis management (COM(2011)0753 – C7-0445/2011 – 2011/0368(COD) – (2013/2505(RSP)) (B7-0003/2013)

These proposals for decisions had been translated into all the official languages and were available on 'Séance en direct'.

If no political group, or group of at least 40 Members, requested within 48 hours that they be considered with a debate and vote, these decisions would be deemed to have been approved

11. Follow-up to a request for the defence of immunity

Following the decision of the European Parliament of 1 December 2011 to waive the parliamentary immunity of Georgios Toussas in connection with legal proceedings before the Court of First Instance of Piraeus (minutes of 1.12.2011, item 6.5), the Greek competent authorities had notified Parliament, pursuant to Rule 7(9), that legal proceedings had ended.

That notification had been forwarded for information to the JURI Committee.
