The sitting opened at 8.35.

The President made a statement following the rejection of the Brexit agreement by the UK House of Commons the previous day. He reaffirmed Parliament's confidence in the EU negotiating team headed by Michel Barnier, and stressed the need to prepare for all eventualities, including that of the UK leaving without a deal. He said that the interests of EU citizens living in the UK and those of UK citizens living throughout the Union had to be taken into account, as did the question of the border between the Republic of Ireland and Northern Ireland.
